This report uses classified leaked high-resolution photos of the destruction of Fukushima originally posted on Pink Tentacle to support its claims.

They are,

1. Reactor 3 is completely missing, which means the press and anyone who has claimed anything about pressures, temperatures, containment, etc. about reactor 3 after March 14 are lying and people need to pay attention to it, because failure of the public to realize the massive extent of the lies about what is going on there will leave the door open to a repeat event.

2. **Reactor 4 is Building 7, demolished by explosives.** Reactor 4 had been defueled and was undergoing replacement of its internal stainless steel shroud, yet blew its containment anyway. That is the FINAL smoking gun, an empty reactor is inert, and cannot produce an explosion, yet one happened at 4 that was so powerful it destroyed the structure leaving it in danger of falling over. Overheated open fuel pools cannot produce hydrogen because in an open fuel pool the water boils off at 100 Celsius, and won't be present in pressurized form at 2,000 degrees Celsius to liberate it's hydrogen by losing it's oxygen to the zircon cladding in the fuel rods. The rods will prefer the free oxygen in the air and burn long before attempting to claim the oxygen in whatever humidity there might be. Because fuel rods only contain 20 percent fissionable material, they also cannot produce the "prompt criticality" "The most qualified nuclear engineer in the world" Arnie Gunderson has spoken of. **I got to the bottom of the Arnie Gunderson story, and added the results of that investigation further down the page.** He has been put on a pedestal and pumped up enormously by a press that wants a misleading story; all the while he is a despised outcast of the greater engineering community. The explosion at #4 was flatly impossible absent the use of an explosive device, and as a result **the disaster at Fukushima is FAR FAR WORSE than ANYTHING Gunderson is willing to say.** Gunderson is towing the line and hiding the true magnitude of what happened there because if it became widely known serious questions would be asked. *When have you heard Gunderson talk about a totally missing reactor?*

Reactor 4's dome was removed for defueling. Drone photos prove it. This dispels the rumors surrounding unit 4's explosion. Some people have said that this reactor was secretly in operation to enrich plutonium. This photo proves it was disassembled for shroud replacement as stated. Tepco is going out of its way trying to explain the explosions, especially at reactor 4, because they did indeed occur, so an explanation is needed. As a result, they are giving reasons that cannot happen, just to say something. They need to see this post and get the Arava perspective (Arava is a district surrounding Dimona).

3. That the destruction of the facility is so severe it could only have been accomplished with nuclear weapons. Hydrogen produces a non-ideal subsonic explosion. It cannot turn concrete into dust. It can produce high pressures if sealed off, but the metal roof on all the reactor containments should have provided the relief and been the only thing destroyed. It takes a high intensity explosive to strip concrete off rebar, a blast wave many times faster than supersonic. This means that whatever happened at Fukushima did not have blast characteristics that fit the "official" story. If you missed it in the high resolution photo of the destroyed facility, I took a car that was laying around in the remains and placed it on top of one of the blown away walls at reactor 3, which clearly gives the reference that the walls had support columns at least 15 feet thick. Fukushima was built with the Mark 1 containment design, but beyond Mark 1 standards which was a common upgrade (reference is the included photos, it is obvious). It is true that gas explosions can be very destructive, but only in facilities that were not designed to handle them. Even the basic mark 1 containment was many times beyond capable of withstanding the worst hydrogen blast.

4. That nuclear weapon(s) were placed inside of the reactor containment(s) disguised as security cameras installed under contract this year by Arava based security firm Magna BSP (Arava is a district around Dimona, not a city.) Their "security cameras" weighed over 1,000 pounds and were the size and shape of gun type nuclear weapons. The reason Magna BSP gave for the odd shape, enormous weight, and giant proportions of their cameras was that they were stereoscopic. They have creatively called them bi-sopic so when you search on google their monstrous cameras are the only thing that

comes up (outside of Dj lighting and a gun scope) **Try it. Type "Biscopic camera" into google images,(without the quotes) it's a hoot!** This helps marketing I guess. The need for such a large stereoscopic camera could be plausible at an airstrip, where the camera would need depth perception out miles, but not indoors where focal lengths are short. Other manufacturers have units appropriate for indoor focal lengths which are only twice the size of ordinary monocular security cameras. Depth perception going out miles could also be accomplished with two separately mounted cameras weighing only a few pounds; the giant thousand pounder is a dead giveaway. **Magna does make passive radar systems which require a large body**, but the owl could accomplish its claimed function with two small lightweight cameras (5 or so lbs, not tiny) and the processor in a modern laptop. Why this giant thing? note - a not yet produced graphical model is what you see most on Google, the ones produced thus far are ugly boxes.

.....9/11, 4/11, 3/11? see a pattern? Let's not see a 6/11. Your time and effort in spreading the word may really make a difference.

The quake was not what we were told.

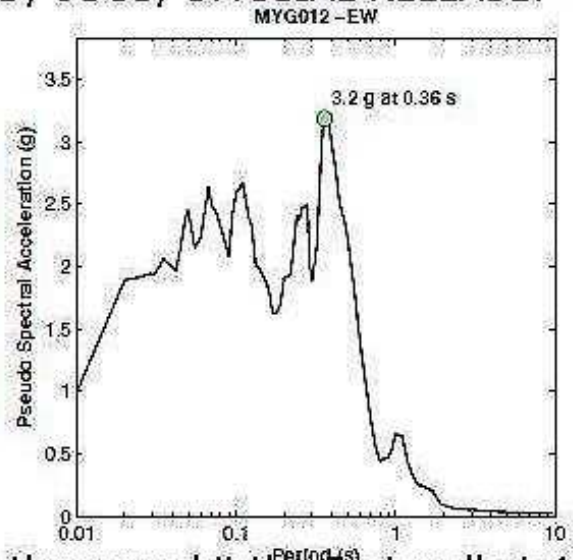
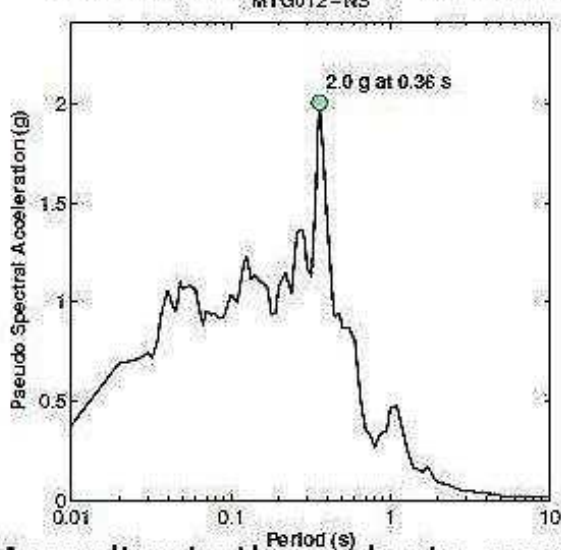

This original seismic data is the smoking gun, however, I have something better. According to these charts, everyone in the room hit the East wall at 44 MPH, and then bounced to the south wall at 28 MPH. Everyone died.



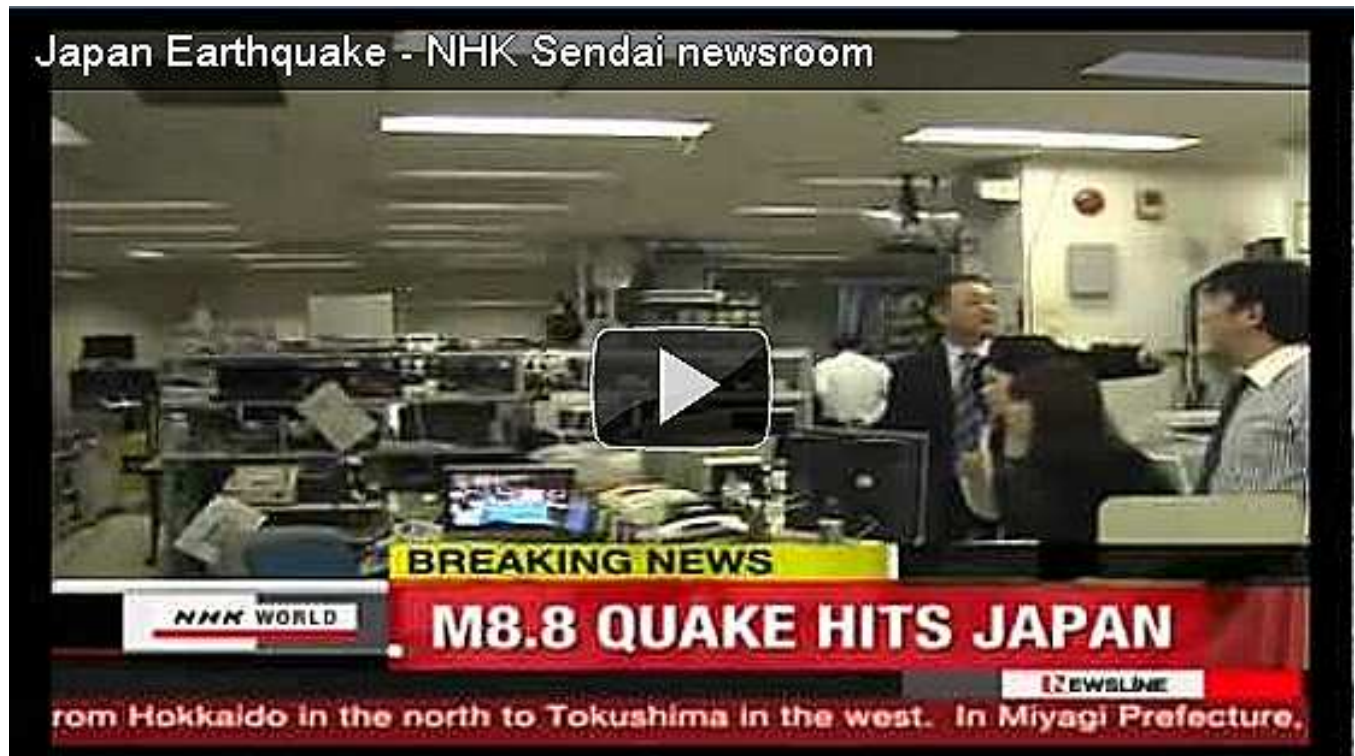

The video below is the one I pulled the frames out of for the sad, sad story. It is a video of a newsroom at the hardest hit area in Japan, and it SAYS IT ALL. This is when the quake was happening live. They are alarmed there is an earthquake, but most people stay seated in their chairs.

Some people even keep typing on their computers as the quake happens.

This video gets deleted off you tube occasionally, if it does not work check back later and I might have re-linked it.



Remember that this video is proof of what really went on. This means there never were significant aftershocks, never was a **natural** tsunami, and if they lied about that, what else? This video is pivotal and vital to exposing the truth. Sure there was a quake, but at this newsroom it was not much over a six if it even was a six. I chose this video because the news room is within eyeshot of station MYG012, which was used by the USGS to make these graphs which represent an 8.8, as was stated in this (English) newscast and was probably used as a guide to fudge the lie due to the closeness of the newsroom to the seismic station. Looking at these charts, it is super easy to get a rough guess at how fast people would have flown. 44MPH to the North, and 28MPH to the East. Those are not precise numbers but the charts are proven wrong by the video because according to the charts people should have entered uncontrolled flight. Here is the full chart put out by the USGS **Of course, they offer no reading from MYG011, which was closest to the 9.0 "epicenter" by a long shot, because it only got a 5.63's worth of shaking.** I will do that work for them. That map is below.

I challenge ANYONE to send me pictures of this quake showing me devastation in an area *not hit by the tsunami*. All we have, all the pictures are tsunami damage. Let's see pictures of quake damage. The Kobe quake was a 6.9/7.2 depending on source. That makes this quake, at a 9.0 100X as powerful. Sendai was near the epicenter and would have been devastated if it really happened. Look at the earthquake photos of damage from the Kobe quake, and try to find ONE THING SIMILAR in SENDAI. Just try. They do not exist. Outside of the tsunami, the quake, which supposedly hit Sendai with many times the power of the one in Kobe, did not destroy a single building there. Sendai was only

48 miles from the epicenter of this "9.0" which would have devastated everything in an area 1,000 miles across if it was real. All of Japan would be toast. **Try to find a photo of seismic damage in Sendai. I challenge you. Try to find it in any of the coastal cities, as little as 25 miles from the "epicenter". I looked for 5 hours, and except for some tanks that fell at a brewery not a single one exists. No pictures of collapsed skyscrapers or high rises equals NO 9.0. You will not find a single skyscraper photo where the windows got broken either. You will find no downed power poles, no flipped over cars, no uprooted trees, no derailed trains (except for one the tsunami hit), and the road damage is typical of even a 5.0. You will not find pictures of a single damaged multi story building or even a structurally damaged wood framed house outside the tsunami zone. In Sendai the quake messed up grocery stores and kitchens and that really is about it.**

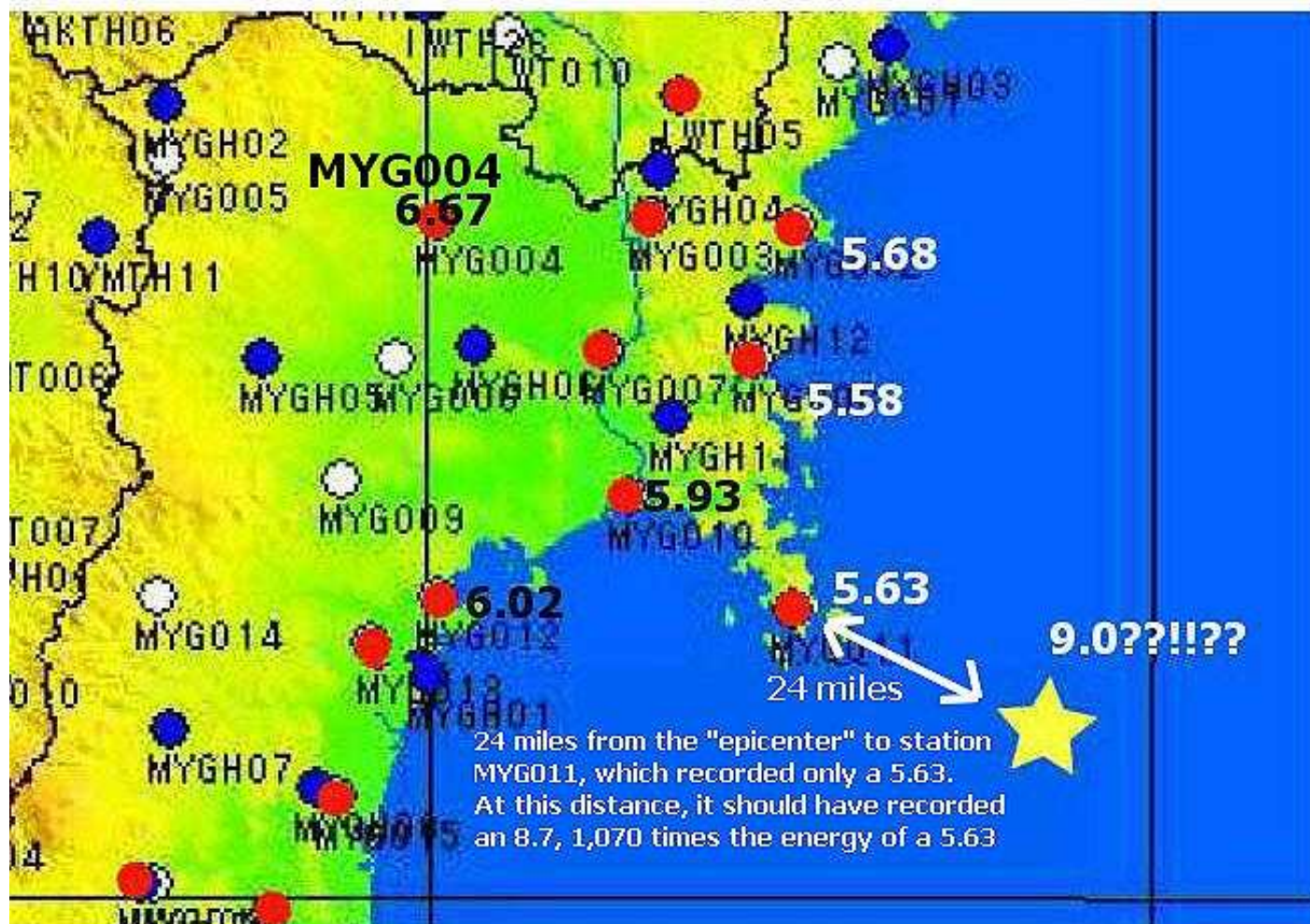
When reviewing the seismic data for the supposed 9.0, I knew there were instead 3 small simultaneous inland epicenters. This made me suspicious right from the start that the quake

So I was hunting for tunnels and lava tubes near each of the three epicenters, and wanted to find them before writing this into this report. As it turns out, I did not need to. 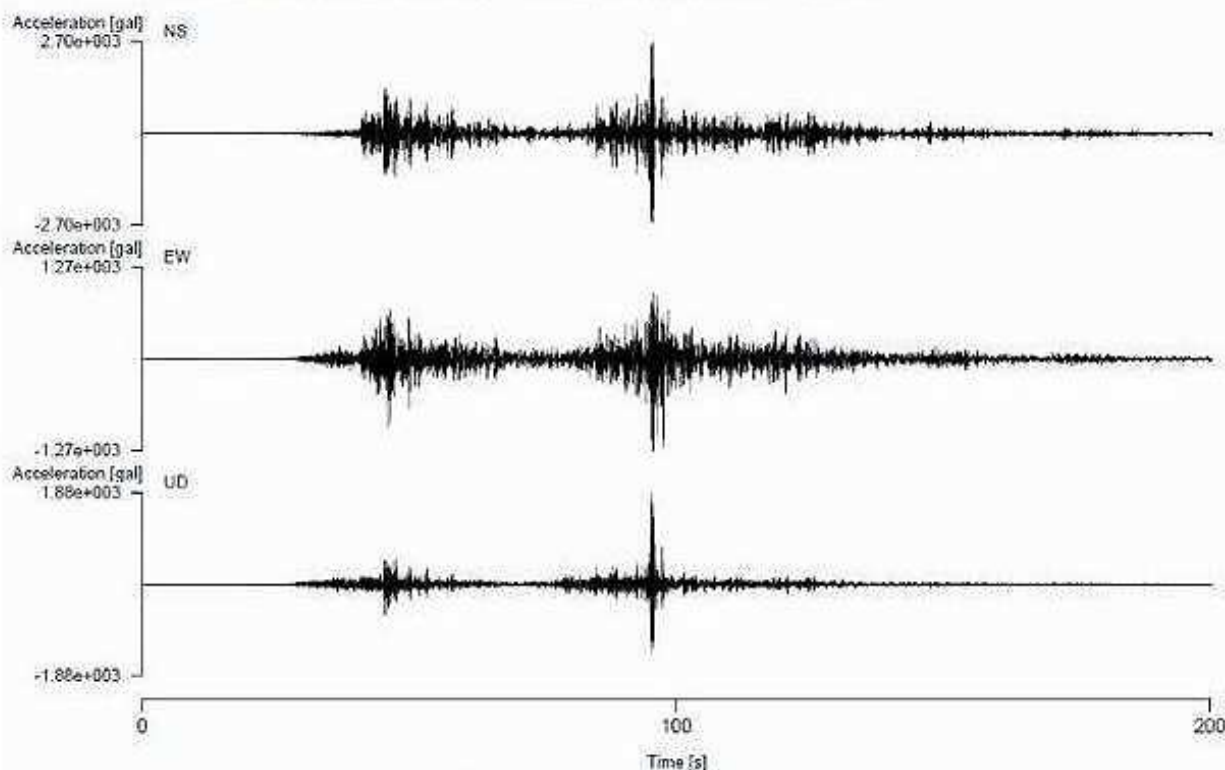
I would expect with 14 years of advancement that these technologies could now trigger devastating earthquakes in non-seismic zones. Bejamin Fulford, an experienced Journalist with a long history and a paid access site, is predicting that the floods along the Mississippi are in fact caused by HAARP, which will then be followed by a manmade earthquake along the New Madrid fault, and then a subsequent attack at 15 reactors in the nation's agricultural heartland. The following picture is the strongest reading for this quake on any seismogram anywhere in Japan. This was before the lie machine got running smoothly. Early on there were a few sputters and this REAL chart got out. As you can see on this chart, it was a 6.67 on the Richter scale (not SHINDO scale, confirmed by PGA reference) This would fit in with NO structural damage in Sendai and the level of shaking in the video

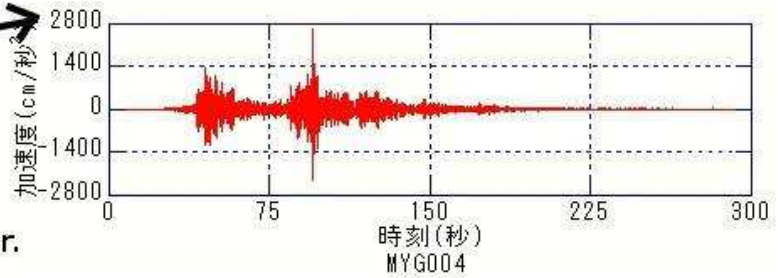


Acceleration recorded at station MYG004 displaying the largest PGA measured (this KNET station is located near Kurihara)

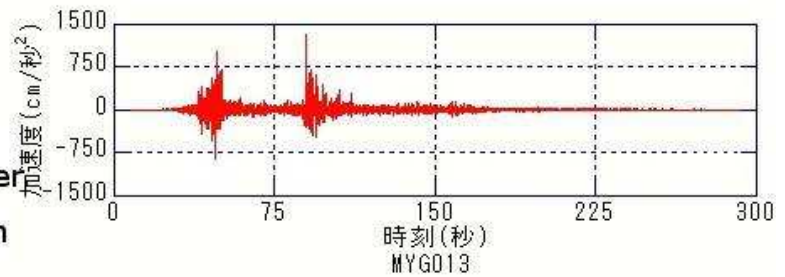
This quake was initially assessed a 6.8, and the seismic data will show anyone the epicenter was inland, not at sea. So it started a 6.8, then got upgraded to a 7.9, then got upgraded to an 8.4, then got upgraded to an 8.8, then got upgraded to a 9.0, and had the epicenter put out in the ocean. Now many are saying it was a 9.1, which would bump up MYG011's number to 1200 from 1070; and it is all based on tsunami effects, not seismic data.

The following seismograms clearly show epicenters from 3 separate small quakes all occurring simultaneously. This is what would be expected of an attack, rather than a natural occurrence.

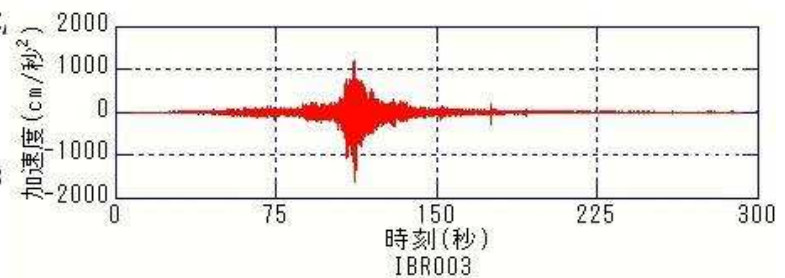
The scale of the measurement is denoted by these numbers. MYG004 looks like a smaller measurement than MYG011 but is in fact much more powerful. The sharp spike in quake 2 shows MYG004 was closest to the epicenter.



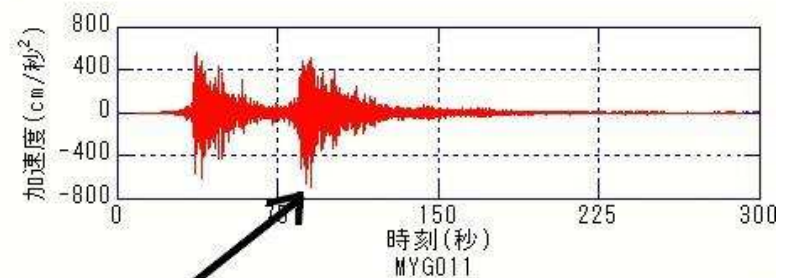
The omission of results from many seismic stations makes it harder to pin down the epicenter of quake 1. MYG013 reads strong and has the spike, but MYG004 is slightly stronger.



All of these quakes took place within the same time frame denoted in seconds at the bottom of each chart, yet IBR003 shows none of the characteristics of the quakes to the north, and is therefore a separate seismic event. This strongly implies the quakes were indeed not natural, if they were, all seismograms would look at least somewhat similar.



Proof of reporting lies. MYG011 was not only closest to the oceanic "epicenter" but it was WAY OUT on a peninsula, drastically away from the main land mass. According to "reports", this measurement should have been strongest. Instead, the chart scales out at 800 and graphs out at 700. In addition to this, it is completely lacking the sharp spike you see near the epicenter of a quake and instead represents a muted rolling echo, similar to the rumble of a distant thunderclap. This proves fraud in reporting of this quake, it could not possibly have originated at sea. Yet the government of Japan is going along with the lie. WHY?



One problem with people grasping how big a 9.0 is,... is that exponential charts will hide how much energy is really being released behind confusing gradient marking. To answer the need for clarity, I got out the calculator and produced a chart that shows you how big a 9.0 earthquake is on a linear scale. Make sure you expand and scroll it; it is 5,000 pixels tall (height). **Due to its large vertical height it opens on the left side of the screen and is almost invisible until you expand it.** Confusion over how GIANT a 9.0 really is has helped the elite scammers enormously in their lie. There is simply no way much of anything will remain standing, yet as the tsunami rolls in

And now, I will bite. This is what I did not want to publish, but I know it has to be true. Call this creative journalism, because I never called Netanyahu, but here is the most rational conclusion I can draw, based on all info gathered so far including the original not faked seismic data.

VLF communications are established with the bomb to penetrate the water. David in Dimona gets seismic reading from Japan. 6.67 in progress, BOOM. (new evidence shows the quake most likely was not natural)

Tsunami comes in, swamps Stuxnet infected power plant, direct video feed from legitimate cameras security company installed gets to David via totally unauthorized channel, and David knows just when to cut the generators off. Others on the team do all they can to counteract measures taken by the employees at Fukushima, who are unaware an attack is taking place and do not understand why everything is going crazy

5. After enough mayhem ensues to provide plausibility, they set off planted nukes and blow the place sky high.

And even if the quake was real, there are nukes that can reach an 8.4. Close enough. Though I have yet to work out the final details, I probably have enough to hang them because:

1. I got the real seismic data that proves beyond a doubt the quake is not what we were told and was in fact an inland 6.8, (calculated higher than the seismogram due to the triangulated true epicenter being a little higher) which would get noticed but not feared in quake ridden Japan.

2. Numerous referenced sources prove Stuxnet really was written by Israel
3. Japan really did offer to enrich Uranium for Iran, and Israel has been documented to have attempted to destroy the reactor in Iran, and probably did. Japan contributing to Iran's nuclear future would make them just as much an enemy to Israel as Iran. Israel would want them taken out.
4. It is documented that a team from Israel, with a history consisting only of working in Israeli defense, got unlimited access to a Japanese nuclear facility, which then went boom
5. Reactor 4 had been defueled and proven disassembled, and therefore no explosion there was possible. What should have happened at reactor 4, if anything at all? the fuel pools should have melted down and caught fire once the water boiled off from lack of recirculation AT Worst, and badly contaminated the containment structure, NOTHING ELSE. NO explosions, NOTHING ELSE. Reactor 4 is building 7, PERIOD. Why did an explosion there happen that was so severe it blew the outer containment walls (4 feet thick) and inner containment walls that were much thicker? Reactor 4 is reportedly now in danger of falling over. HOW?
6. The Japanese government is going along with the story of a scientifically proven false 9.0. Is it not interesting this "quake" reportedly happened at the bottom of the Japan Trench, which would be perfect for hiding an atomic bomb blast?

Is the Department of Homeland Security trying to keep American industries (and nuclear facilities) in the dark about Stuxnet? After Fukushima fell victim to unwary operators, I would think such a conference would be a TOP priority here! The genie is out of the bottle. It is a fact that the writers of Stuxnet intend to use it. Fukushima was impossible. The swamping of the external generators by the tsunami was irrelevant, because the real emergency backup systems are driven by steam from the reactors themselves. No electricity is needed to operate three separate emergency systems at each reactor, each of which will keep a reactor safe even if only one works. Interesting it is then that all 9 non-electrical backup systems across the three-fueled reactors failed. This is technically impossible outside of willful intent, and was likely the result of a Stuxnet attack.

Stuxnet was designed specifically to target Siemens SCADA controllers and is most effective at tampering with fluid control systems. The centrifuges it attacked in Iran were ideal. So are the fluid control systems at a nuclear facility. Oil refineries are equally at risk, Stuxnet is most dangerous when affecting a system which needs to control the flow of any liquid, be it hydraulic, for cooling, or combining chemicals. Stuxnet is documented to have been produced by the Israeli Defense Forces, for the purpose of destroying any industrial system that can be destroyed by improper fluid flow.

Magna BSP, a Dimona based company with no history outside of IDF contracts prior to Fukushima has a suspiciously short domain history despite a 10 year claimed history. Magna BSP had a full time Internet linked two-way connection to the Fukushima reactor room(s) all the way through the disaster. They told TEPCO about that connection on March 15 (after everything blew sky high) via an article printed in the Jerusalem Post. Why did Manga BSP wait until everything was blown sky high to tell Tepco the data link existed, and then did not tell them face-to-face? I find it hard to believe that TEPCO would not have been interested in viewing a reactor that was about to explode. It seems impossible that Tepco would not have wanted to view the reactor, and probably did not ask because the link was kept a secret. It is a simple fact that Internet connections are never allowed inside a reactor's containment. The connection was mentioned in the Jerusalem Post AFTER the destruction was finalized.

Stuxnet has two modes, random and administrative. It can be administered to optimize the damage and can also transmit setup information and industrial system information to a remote computer. Once installed on the host system via a flash drive it causes that system to violate it's normal security protocols and Internet administration becomes possible if a connection exists. Tampering is not visible on the control room readouts, because Stuxnet learns what "normal" looks like and keeps the

temperature, pressure, and other readouts within normal limits so that the operators are oblivious to the destruction happening in secret. Stuxnet appeared in Japan in June of 2010, shortly after Magna BSP arrived. Remote administration mode can be adjusted on demand to suit any need. No doubt the people at Fukushima sat there in idle mode thinking all was well until something screamed or went boom and at that point it would be too late to do anything other than cry.

I am a lifer in the types of control systems Fukushima and its clone, TVA owned Browns Ferry have. BOTH have been upgraded to modern Siemens controllers running the Supervisory Control And Data Acquisition (SCADA) system Stuxnet was designed to attack; upgrades are the norm in any major facility. On many blogs people say the controls were old and therefore Stuxnet immune; they are out of touch or have no knowledge of industrial control systems. I actually ferreted it out.

*And now I will explain in detail why the problems before the explosions had to be **sabotage***

The diesel generators were not out in the open as we were led to believe, they were in fact located in the basements of the turbine buildings which were sealed off and never significantly flooded. One of them stayed running the entire time, but the electrical switchgear attached to it disconnected it for an unexplained reason, which made it useless. Each of the backup generators at Fukushima were capable of running 14,000 households each, which means they had to be over ten megawatts each. It is obvious then that Fukushima was set up to survive on only ONE of 13 backup generators, and ONE did keep running. One would be many times larger than needed to run last-ditch backup systems at all reactors, but would not keep business as usual. But that is not the real story, which is that even others, which were high and dry, stopped as well.

I hypothesize that the ONE generator that kept running was kept as a lone reserve, never hooked up to a SCADA controller. Why did the switchgear disconnect a working generator? That is the type of thing Stuxnet was designed to do. On top of these things, emergency generators arrived on scene within 9 hours, before anything bad happened at all but were not able to provide power because the switchgear would not let them. This deceptively written report from the World Nuclear Association contains all this information, but it is presented in a way which will cause you to overlook these things if you are not careful while reading it. This report contains accurate information presented in a very misleading way, which will protect the liars who wrote it - they actually did speak the truth here but in a way it would be missed by virtually anyone. Study the facts presented here with the full ramifications of those facts in mind, not their shallow misleading conclusions.

From this report you can get:

1. The generators never got submerged - you have to connect the dot between them being in a contained area and the tsunami thereby not being able to get to them. Some water got into one of the turbine buildings where several were located and flooded the lowest point in that building to a depth of 4 feet, which means that even if the generators were on the floor at the lowest point they likely would not have been swamped because they are too big - the water would not get past the footings. Perhaps a one-megawatt generator would have swamped; certainly not one of the big diesels, which were, according to this report enough to run 14,000 homes each. In addition to this, there were several generators in a second location that never got flooded at all. One of these generators kept running but was not able to get power into the facility because the switchgear prevented it.

2. You have to have watched the robot videos, which clearly show the switchgear that malfunctioned after the tsunami never got wet - there was a non-tsunami reason for the failure. Also look at the high-resolution photos referenced below. There is no switchgear for the diesel generators outside the facility,.... it is all indoors... and ONLY in areas higher than the water got. Remember that there was no emergency when the off site generators arrived, which means that they could work efficiently to get things up and running. With my experience in this area, assuming it DID get soaked, a complete replacement of high capacity switchgear should only take an afternoon if done with an emergency attitude. A truck mounted crane or a forklift does all the heavy lifting and the stuff is modular. In every major facility there are spares galore. It is not that hard to make the terminations. A worst-case scenario

could have been addressed before things went horribly awry, that is, unless a virus did not let the new switchgear activate either. It would take days to conclude a virus was messing things up. You would not expect that. I am sure there is a LOT we never heard about.

3. That batteries held, leaving only a one hour gap in time where there was no power present to run things before adequate off site power drove into the facility on the road all nice and ready to hook up, but was denied to by switch gear which this report says was swamped but that is likely an assumption because swamped switchgear could have been replaced even before the batteries died. The fact that the offsite generators were able to be driven into the facility also proves that other lies told about the earthquake in general - employees leaving only to find cracks in the road so bad they had to walk home; Why? Why lie like this? AT LEAST this report has some modicum of honesty.

4. You have to look at the chart that shows the thermal output of the reactors 8 hours after the earthquake, which is when the batteries running the electrical cooling pumps died, the output at that time was less than 20 megawatts from each reactor, which means that they would not have had troubles before the off site generators were hooked up to restore power if it was not denied by what I suspect was Stuxnet infected switch gear. The real critical time is in the first 3 hours after shutdown.

5. Reactor 3 exploded entirely, yet this reactor had the most functional backup systems. At least this report says the explosion remains "unexplained". Perhaps those who wrote the report should take a look at [this](#) for an answer.

6. The reactors are stated to be an "early 1960's design" apparently to mislead people into believing they were outdated even when installed. This was not the case. Their design was an early 60's concept but in fact a late 60's design, and since installation takes years, what more could you expect in the early 70's? The reactors were in fact a very safe design. This report at least states that the facility was very well updated. Identical reactors at TVA owned browns ferry have been certified safe and licensed to operate through the year 2035. These reactors were also converted over to run the Siemens Scada system. The reactors at Fukushima were not garbage. The fastest cars in production still function on a late 1800's concept.

I hypothesize that the situation at Fukushima is not being properly assessed by facility controllers, because STUXNET is STILL giving false readings to the control panels, readings which obviously have to be false because they show containment pressure when confidential leaked photographs prove beyond a doubt **no containment exists AT ALL at reactor 3. There is not even a reactor there.**

This report is perfectly inaccurate with regard to reactor 3 containment. Perhaps the people who wrote this report have not actually looked at the facility or seen the confidential photographs.

This report supports what I have said here entirely. It was written by an experienced reactor operator. I found this on May 10. I was absolutely right!

Each reactor has 8 separate emergency backup systems, each capable of saving the reactor on it's own. **Three are designed to function perfectly if all power is lost and even the generators fail.** Fukushima did not need any electrical systems operating AT ALL to keep itself from blowing up, when power is lost steam from the reactors is automatically diverted from the generator turbines to two totally separate steam turbines connected to totally separate water pumps needing only reactor steam to power them. Even that backup system has dual redundancy; only one of the two is needed for the job. But the valves, which have to activate to re-divert the steam, all 6 valves on a total of 3 fueled reactors, eventually failed to. At reactors 1 and 3 these systems worked, but switched off at reactor 1 within an hour and off at reactor 3 after running for more than two days. No one has been able to explain why these systems switched off all by themselves, when they need a powered command to switch off. At reactor 2 they were never allowed to activate. This can only happen if the control system tells them to shut off or stay off, absent intervention from the controller they automatically and seamlessly switch cooling modes to passive rather than electrical.

Some readers may remember that the real issue at Fukushima was malfunctioning valves, and the need to get someone past the radiation to open them. These are the valves that were spoken of. Because Stuxnet kept the readouts normal, no one knew this system did not function until major problems happened as a result flooding the area where the valves are with radiation. This prevented last ditch efforts (running and cutting the wires). One automatic valve jamming and mechanically failing would be a surprise, 6 failing can only be **sabotage**.

In addition to this, another completely independent separately piped backup with an entirely different electronic decision tree which injects borated water at a pre charged 3,500 PSI into the reactor to irrevocably shut down all chain reactions (reactor rebuild required) also simultaneously failed at all 3 fueled reactors. The borated water systems have explosive operated valves so reliable that even one out of 3 failing would be a ten thousand to one possibility, if that. The reliability of the borated water systems is technically theoretically assured. All three failing at the same time at Fukushima can only mean **sabotage**.

High pressure in all of the reactors proves the quake did not damage any of the infrastructures at Fukushima because any leaks would have let the pressure go. In addition to this, the seismic readings at Fukushima were 6.07 Fukushima was designed to handle being at the epicenter of an 8.

The media keeps harping about how all the water went away. It only did because these three backup systems were prevented from cooling the reactor, which caused the water to boil off and never be replaced. High pressures were talked about constantly in the press; this means beyond a doubt that all 6 steam powered backup systems were intact, and all 3 borated water systems were intact also because if they were not the pressure would have escaped through them. Absent emergency backup control power keeping the virus alive; (control power Magna BSP admitted was there the whole time by mistake when they said their cameras and supporting computers captured the explosions and maintained a data link) the valves which control these systems would have opened when the generators failed and there would have been no disaster. 3 worst case scenarios where all 9 automatic valves across 9 separate emergency backup systems are held shut by the controller when no power should have been present to prevent them from activating can only mean **sabotage**.

A historical perspective of Fukushima shows the hydrogen blasts were bogus.

Hydrogen blasts could not have damaged Fukushima so badly; this is a media fed lie. If hydrogen gas alone mixed with air could produce blasts strong enough to blow reactor containment buildings to pieces, which are among the strongest structures on earth (exceeded in strength only by ones like Hoover Dam,) then hydrogen gas filled bombs would be the prime military option. In reality, the **Three Mile Island incident proved hydrogen ignition in open air after reactor meltdown is likely to only scare employees, while causing no damage at all to the facility, as was the case there.** It is extremely important to know the differences between the boiling water reactor design and the design of Chernobyl. At Chernobyl, a hydrogen blast DID cause destruction of the facility, but it was because the reactor design caused hydrogen and oxygen at a perfect ratio to ignite at thousands of PSI *inside* the reactor pressure vessel. That's a big difference from hydrogen alone igniting in relatively oxygen starved open air at one atmosphere (14.5 PSI). The difference would be similar to the difference between a small firecracker and a case of dynamite; there were many orders of magnitude lower blast potential at Fukushima.

Just to be absolutely safe after the Three Mile Island incident, many nuclear facilities installed hydrogen hard vent stacks hooked directly up to the relief valves on their reactors, and Fukushima was one of them. This was to prevent a hydrogen buildup in the containment building in the event of a core meltdown, which caused a minor explosion at Three Mile Island. These stacks are the tall white towers you see in the photographs of Fukushima, and they are effective in getting rid of hydrogen buildup, are directly piped, and vent completely outside. "Hard piped" means that the electrical failures would have had nothing to do with the blasts, because a hard vent is exactly that - no fan needed at all because the system is sealed. Even if the hard piping at all 3 fueled Fukushima reactors failed entirely, it should not have been any worse than Three Mile Island which did not have any hard venting to begin with. While

hydrogen venting might be a problem if it ignited, it would not mean the death of a facility. It makes no sense that at Fukushima we got a nuclear weapon style mushroom cloud far in excess of the highest yield conventional bomb.

Below are the classified photos

What then, caused the explosions? The containment walls were at their thinnest points in the lowest allowed General Electric design a minimum of 4 foot thick steel reinforced concrete, were likely to be a minimum of 8 feet thick, and were totally blown away. All concrete was stripped from the rebar, which was left dangling. Reactor 3 vanished entirely, as seen in the classified photo used to compare the destruction to the diagram and reactor 4 appears to have been blown to pieces as seen in this classified photo. The yellow dome which should be sitting on top of reactor 4 can be clearly seen on the wrong side of the containment building. This type of destruction is indicative of hard weaponry in use; a hydrogen air mix will not do that. Reactors are not made out of tinfoil. On top of this, there was no potential for an explosion at reactor 4 at all; it had been defueled. SO WHAT, PRAY TELL, BLEW IT APART? That's the dirty question no one is asking - how did that happen?

To give you an idea of how big the reactors at Fukushima were, look at this. It's the top of the same make and model at Fukushima's American twin, TVA owned Brown's Ferry, and it is only the top. The yellow dome sits above this, and is even bigger. (here the yellow dome has been removed for refueling). over 150 feet of reactor sits below that cap. Hydrogen will not vaporize that, which appears to be what happened to #3, only a nuclear weapon would. Reactors are about 14 digits beyond incapable of going supercritical even with a complete core meltdown. The reactors did not explode, something placed in their vicinity did.

Magna BSP had access to the reactors at this facility. They were based in Dimona, which is a military base that manufactures nuclear weapons. Stuxnet was made in their yard. They are stated to be a military company.

There is extremely strong evidence that Dimona based Magna BSP placed nuclear weapons at the exploded or vanished reactors at Fukushima, possibly hidden inside one of their unbelievably GIANT stereoscopic cameras. These cameras were installed inside the reactor containment of Fukushima reactor 3 under the cover of a security contract in the year prior to the disaster. These cameras are identical in size and appearance to a gun type nuclear weapon. Since previous hydrogen explosions at boiling water reactors have never caused any sort of damage to equipment or buildings, even during complete meltdowns, it begs the question how on earth one at reactor 3 produced a mushroom cloud. Three Mile Island sits in the evidence pool against what we have been told about Fukushima. History does matter.

One problem with the reporting in the mainstream media is that it failed to convey just how massive and strong the containment structures really were, as seen in this classified photo. A hydrogen explosion would only blow the sheet metal off the steel framed roof if it even did that, at Three Mile Island the hydrogen ignition did nothing at all. It just scared employees. Another thing the reporting failed to convey is the gravity of the disaster. Compare the containment diagram to the remains of reactor 3. It is painfully obvious that many tons of highly radioactive plutonium in the containment pools is nowhere to be found, the entire floor they were on is completely gone. We are getting lied to.

That was a LOT more than a hydrogen blast, and as a result there are thousands of pounds of plutonium scattered everywhere. TEPCO was ridiculed for initially stating that the radiation from the facility was "immeasurable". I think they at first told the truth. Now they have this story about the Fukushima 50. Is it in fact a "wag the dog"? No one could be there and live. Why is remote controlled heavy equipment doing the cleanup? The official story is hydrogen blasts, not nukes, so the story line has to at least be within the far outer limits of what a hydrogen blast could actually accomplish; not missing reactors and entire fuel pools blown away.

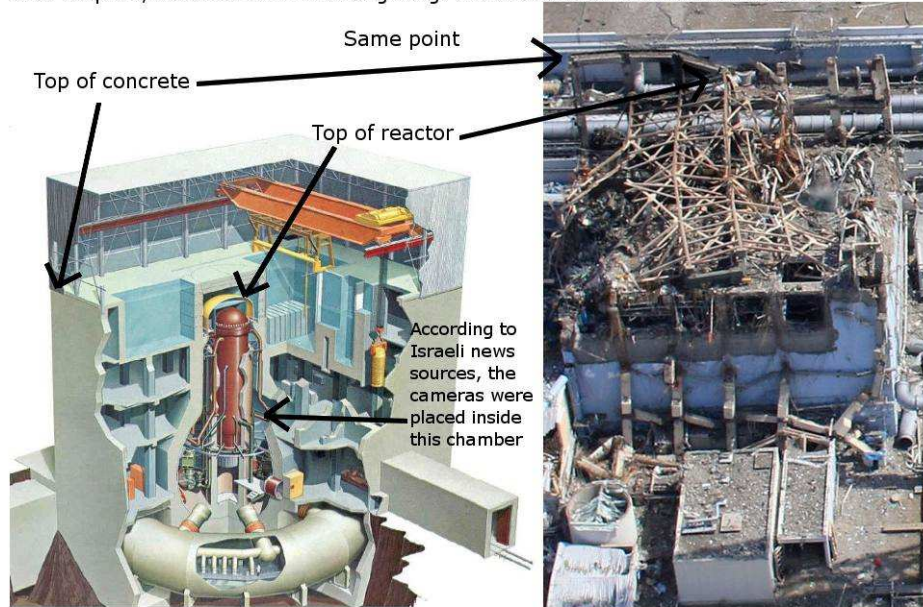

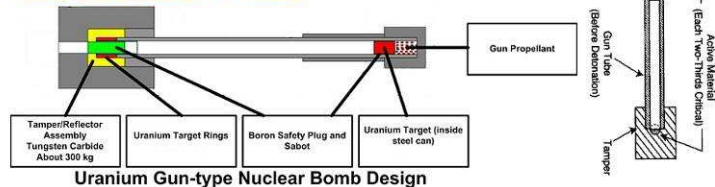

We were lied to about Fukushima, and will continue to be lied to. Three Mile Island sits in the evidence pool against what we have been told about Fukushima. History does matter.

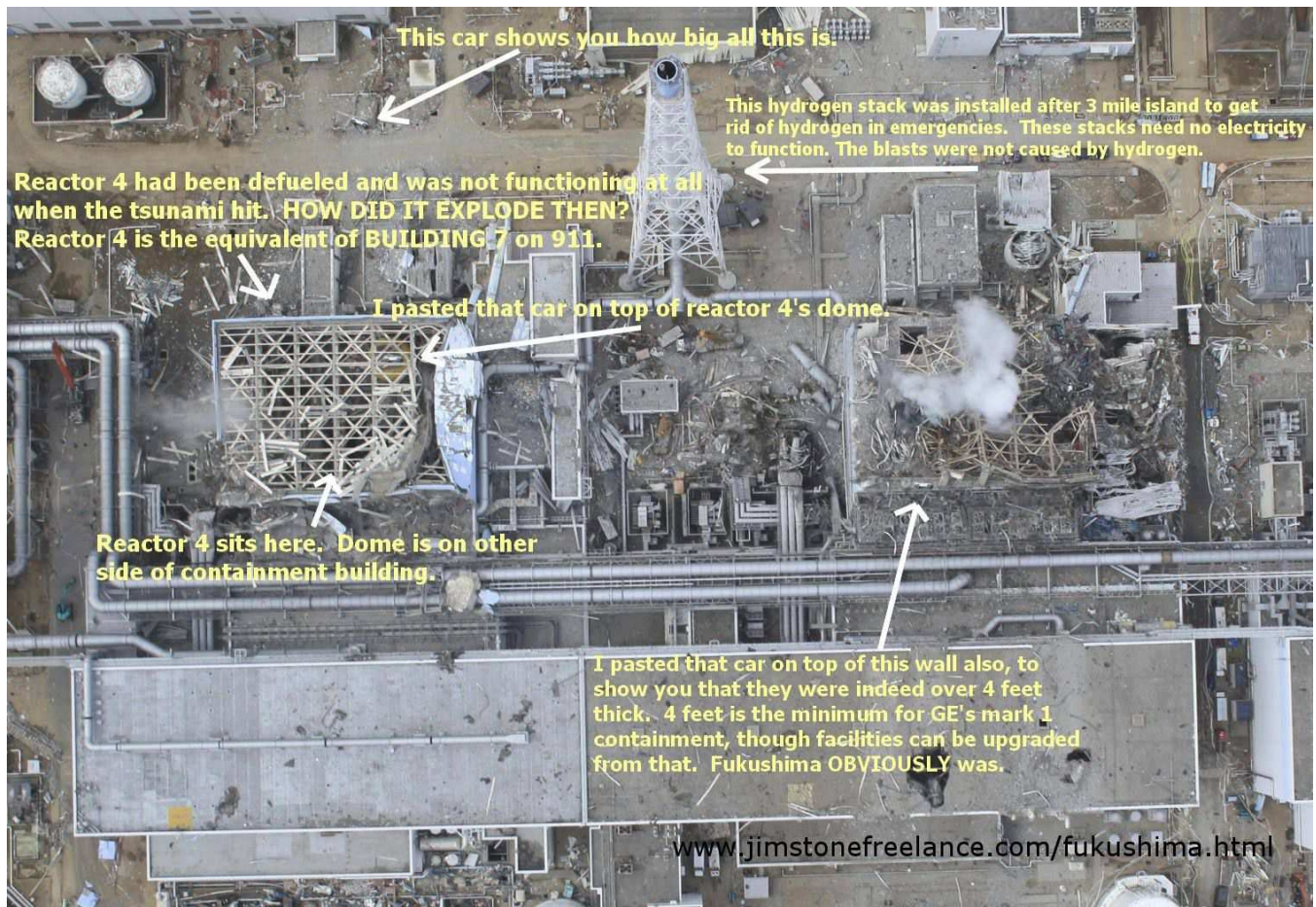
These are diagrams of gun type nuclear weapons, in comparison to one of the cameras Magna BSP brought into Fukushima.



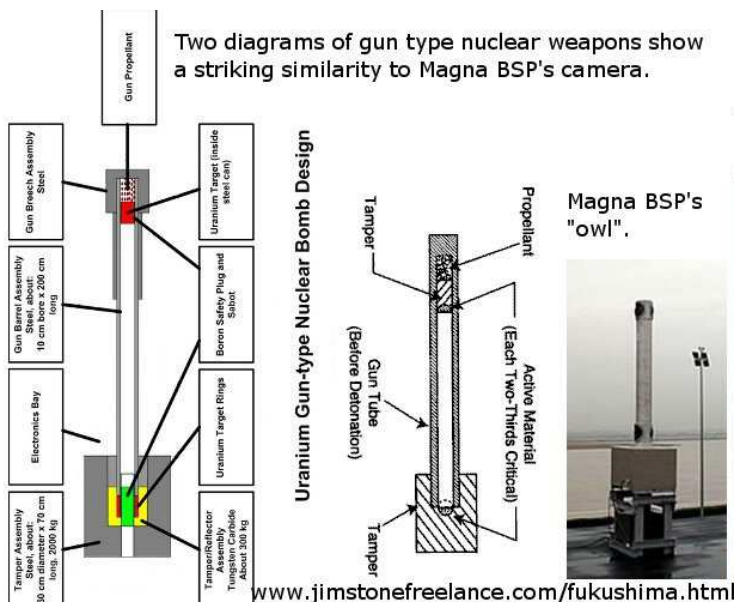
Magna BSP's "owl".



Destroyed Facility

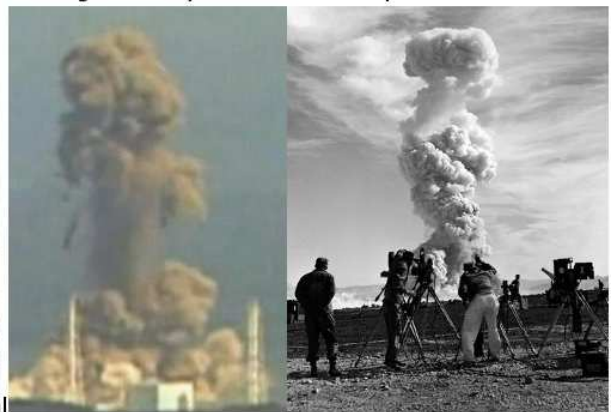


Magna BSP's Camera

An open letter to Tepco President, Masataka Shimizu

I apologize for not being able to speak your language; perhaps you speak mine.

Illusions can own us, and the truth can free us. I believe right from the beginning that you believed you were telling the truth, because you were speaking from within the realm of what is technically possible.

No doubt you had your nuclear engineers advising you as to what was technically possible at Fukushima Daiichi. They were right.

When I heard of the type of apology you made, it hit my heart, and accelerated my search for the truth.

At present I believe you are a victim of misinformation with regard to what really happened at Fukushima Daiichi. As far as your responsibility for what happened there, advisors within your company are probably right. There was no way this could have happened.

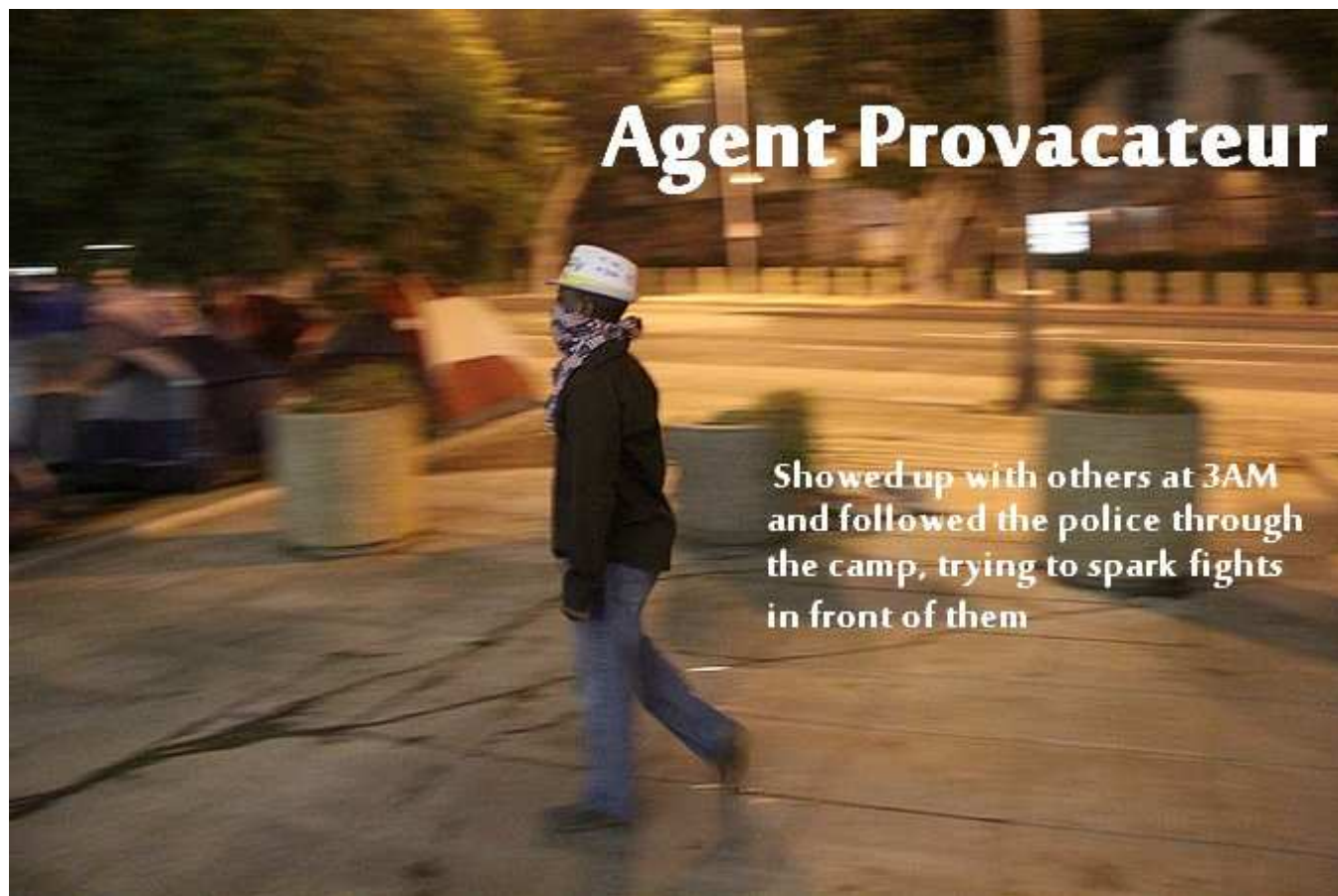

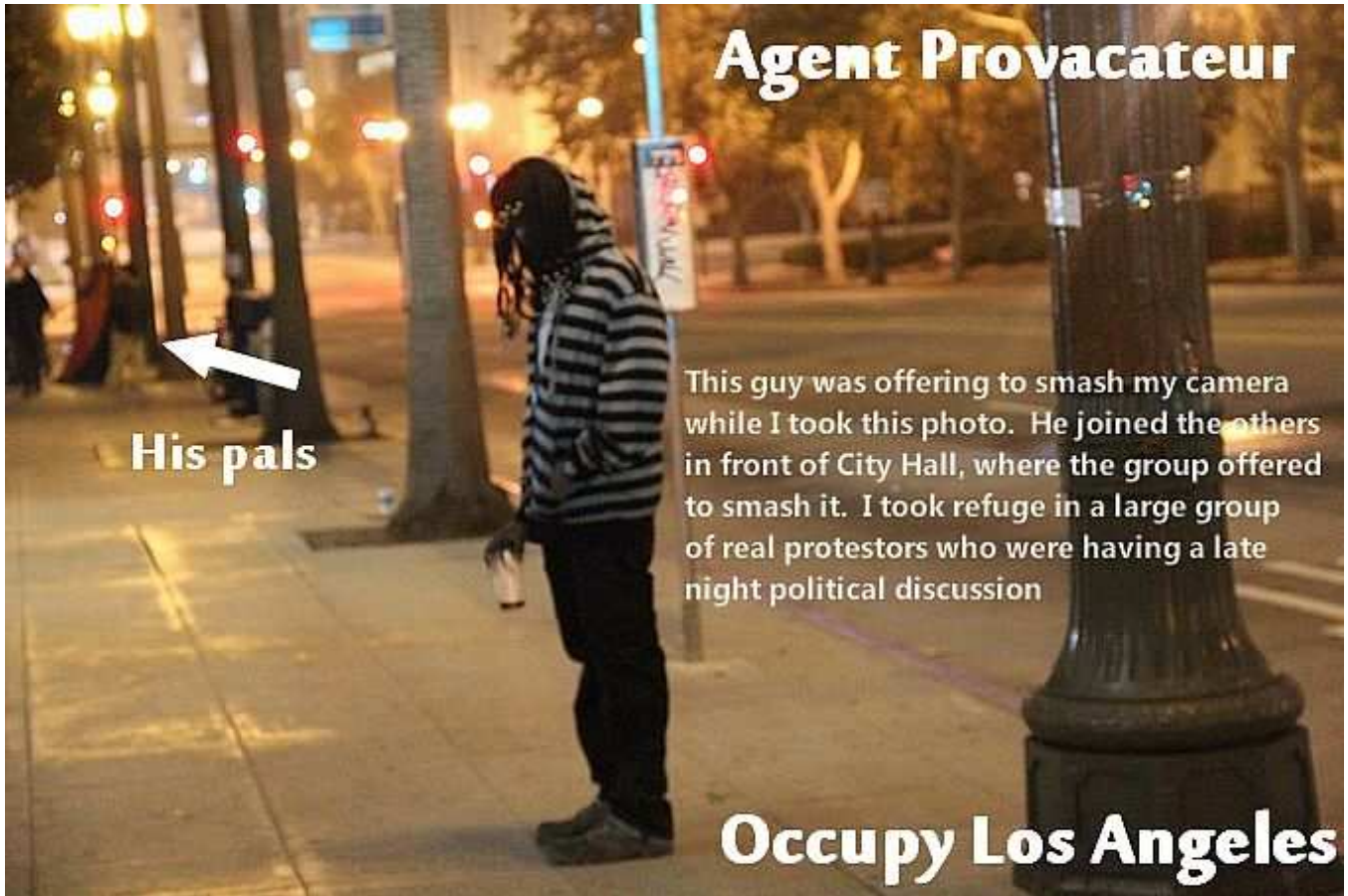

This is another guy with the same laptop, who just does not fit in. I have not yet seen the third.

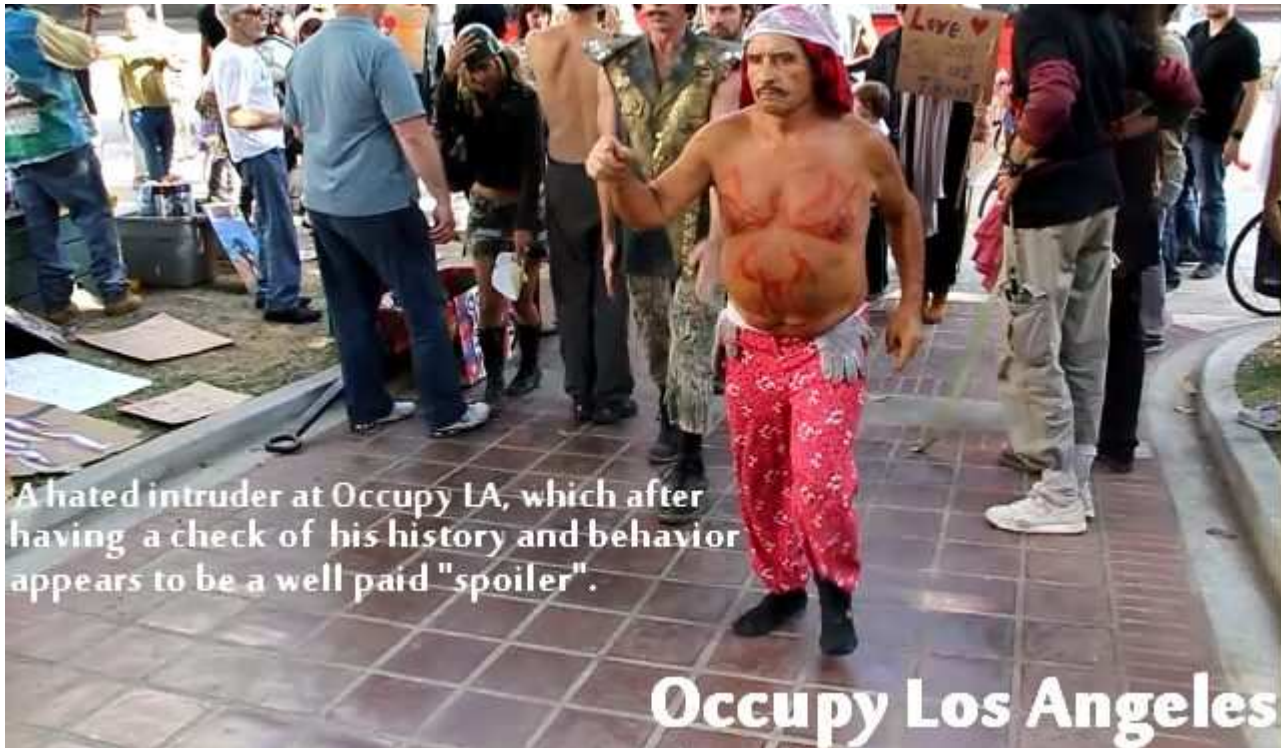


There are good undercover police on scene also. These guys never cause any trouble, and in many cases even appear to help. Many of the police, after all, seem to be on our side at Occupy LA.

POWER GRID TAMPERING WILL END AN ERA ([back](#))

See the update, which answers a question about DC connected main lines below this report. The entire premise of my report is based on the fact that you cannot run multiple frequencies simultaneously on the grid without separating it into sections and running them separately. That is what the AP report clearly implies when it says that clocks will run faster and slower in various regions.

A recent AP report states that there is a proposal in place to change the frequency various parts of the national electrical grid run at. The frequency differences will be minor, but will force an end to the national grid as we know it. The only way frequencies can be different at all in separate locations around the nation is to not have a grid at all.

They are attempting to childishly play this down as something that will mess up clocks. But what it really means is that they are going to dismantle the national power grid entirely.

And now I will dissect and shred this article

First of all, they are saying that this is going to be a "year long experiment". It won't be. Since dismantling the grid amounts to an act of war, once it is dismantled we will not get it back. This "experiment" is exactly what you would want to do to a nation as a pre-emptive measure before attacking it. When destroying a nation, the basics have to go. You need to destroy the water, electrical, and food supplies to force people to surrender. By running different frequencies in different parts of the grid, the laws of physics clearly dictate that it has to be run in sections, all isolated from each other.

Many readers know that one of the strengths of the Internet is its distributed data paths, which make it very difficult to take down. If a line gets cut, you can just re-route through a different line, and all is well. Our interconnected power grid, which has been in place and running synchronously with perfect phase and frequency matching across its entirety since 1930, is an electrical equivalent of the internet, and is a marvel of the world.

Our intact electrical grid will feed power to areas that have lost it, and keep their lights on. So let's say a hurricane takes out Louisiana and all their generating facilities are damaged - the grid will provide power from Texas to help them get back on their feet. If you want to knock out power in a war, you would need to isolate Louisiana FIRST so that Texas could not feed them after you destroyed their infrastructure. This is the only truthful reason why anyone would suggest dismantling one of our greatest national treasures.

We have in America a system, which would allow Hoover dam to provide power to Boston. But those days have to end before an experiment like the one this article discusses can even happen. Here is why:

The article states: "The group that oversees the U.S. power grid is proposing an experiment would allow more frequency variation than it does now without corrections, according to a company presentation obtained by The Associated Press".

Here they say they will allow "more frequency variation". Well, that means that after most of a century of having zero frequency variation, that there will now be frequency variation. America's power grid has been perfectly synchronized since 1930 and has never varied by more than 1/10th of a cycle (1/600th of a second) from coast to coast in over 80 years. This is due largely to the fact that the grid causes generating facilities to lock into each other, and mimic each other's phasing exactly. Any deviation in any one facility against the predominant phasing of the grid will cause it to lose efficiency and in extreme cases be destroyed.

To say they will allow "MORE frequency variation" is a lie, because it implies there WAS frequency variation. THERE NEVER WAS, EVER. That is why clocks have used the grid frequency as a reference for 4 generations.

Folks, you cannot have any frequency variation on an interconnected electrical grid. This is because our 60 hz AC is a rising and falling wave form which goes from negative to positive 60 times a second. Negative and positive ALWAYS have to line up. If you deviate from a 60 hz frequency by even 0.001 hz on only one part of the grid, all it will take is ten seconds for that variation in frequency to cause it to begin rising and falling opposite to the rest of the grid. That would represent a positive to negative electrical short right from within the fabric of the grid itself. So there is no such thing as a "slightly faster running grid" out east, it's a bold faced lie completely counter to the laws of physics.

HERE IS ANOTHER LIE TO SHRED:

"The North American Electric Reliability Corp. runs the nation's interlocking web of transmission lines and power plants."

No they don't. No one company manages the grid. It is managed via cooperation and understanding of the laws of physics. This company is merely now the face of the lie. The fact that they have a long history has been SHREDDDED by this proposal of theirs, businesses come and go, and these people need to head on out the door.

I myself have had to make calls for power allocations to avoid regional blackouts when demand was predicted to be high, and I certainly never called these folks! I just called the facility feeding us and THEY handled it. If they could not handle it, they had the power routed from another area. So for the North American Electric Reliability Corp. to say they manage it all is quite a statement! How do we know they are not a front company, set up as a bogus pre-paid corporation with a purchased "history"? I have a LOT of experience, and NEVER HEARD OF THEM.

And now the math, which proves them liars.

Here is how you prove that the real goal is to dismantle the grid.

Their claim was that they wanted an allowed deviation of 20 minutes per year on one coast in comparison with the opposite coast. So let's take 20 minutes and multiply it by 60 seconds. That's 1200 seconds. Then divide that by days in a year (365) which will give you 3.287 seconds of deviation PER DAY. Take that number and divide it by hours (24) and that gives you a deviation of 0.136 seconds per hour. Divide that by 60 minutes and the deviation is 0.0022826 seconds per minute. Divide that by 60 again. That gives you a deviation of 0.000038 seconds per second. Now MULTIPLY that by your cycles PER SECOND, which is 60. Right back to 0.0022826 phase difference per second.

Now here is where it gets interesting. Let's say I am running a 600,000 volt line. Since the frequency we are dealing with is 60 Hz, it fits perfectly into the equation. Multiply 0.0022826 as a representation of percentage by 600,000 volts. AC has a positive and negative cycle, which effectively doubles that rate, for a total of 0.0045652% per second. Multiply that by 600,000 volts, and the voltage creep equals 2739 volts per SECOND. The math is pretty simple from there. One minute (60 seconds) x 2,739 volts will equal a 164,347 volt difference in phasing between interconnected coasts per minute. Major problems will happen within 15 seconds. Total phase desynchronization will occur in a little under three minutes.

This serves to prove that no frequency deviation at all can be tolerated in an interconnected grid and that this agency - the so called "North American Electrical Reliability Corp" is lying out their butt in this news release and therefore can only have been usurped by either paper trained idiots or an enemy that wants an end to the American power grid, because allowing "frequency variation" can mean only that. The AP article should finish them, OUT OF BUSINESS.

The bottom line? The American power grid, at no time ever in the last 80 years has ever been out of synchronization, by more than 0.001 second total per year coast to coast. The laws of physics will not allow it. We cannot allow ANYONE to disconnect our grid. 20 minutes a year would not cut it in Timbuktu! Not even 1/60th of 1 second would. It is a mathematical impossibility to have ANY deviation on an interconnected grid.

And it gets worse

When it comes to phase correlation, momentum can be the enemy.

The generators at electrical facilities are ENORMOUS. People may not realize how big they really are. Large electrical facilities need to be spun up before going online, it takes a long time to get the enormous mass of the generator moving and stabilized, sometimes even hours. Even modest generators are so big that the spinning mass can weigh hundreds of tons, and surface speeds of the armatures can be over 100 MPH. That's a LOT of speed on a LOT of mass. The massive size of these generators helps them be perfectly stable when running. There is so much momentum built up in a large industrial generator that even enormous peak draws from it can be soaked up without it being perceptibly slowed by the peaks at all.

If an enemy was running the government then, and people were happy to have frequencies changed for no good reason at all, electrical "tug of wars" between generators could be set up under the premise of "oops" to destroy them. Breaker disconnects under such situations are often unsuccessful due to contacts getting welded. I have seen problems happen in even tiny one-megawatt units, where a controller malfunctioned and dropped them onto the same line when their phasing was only off by a fraction of a percent. One was going very slightly ahead the other, so it drove the other to go faster while the other slowed it down. The over-reactions were extreme; they ponged each other's speed up and down and the accelerations/decelerations were enormous, taking place within fractions of a second. I fully expected the windings to explode. I was blown away by how extreme their behavior was.

Even a pair of small generators can be caused to totally freak out from an initial phasing difference that is very minor. This problem would be greatly exacerbated in a power play between multiple enormous generators. Electrical explosions would no doubt result, in the case I witnessed; they both got the right bounce within a couple seconds and stabilized. It was a brief and exciting event. Things are normally not so lucky and the answer is obvious - If you want no problems in the electrical grid, a perfect standard frequency should be the norm, as it always has been for over 80 years.

However, if you were an enemy in possession of a virus like Stuxnet, a non-interconnected grid with all the switch gear from when it was previously connected still in place to play with could be lots of FUN!. To blow out two regions at the same time, all you would have to do is activate switchgear that is already in place from the old grid when both regions are out of phase with each other. Doing so would cause serious damage to equipment in both regions.

Want to blow a nuclear reactor? Here's a good way to try! SUDDENLY and without announcement, introduce a frequency difference on the grid. Suddenly that nuke plant would be forced to deal with a rapid phase inversion on the grid. With all the stored momentum in the generators available for a nice peak surge output, thousands and thousands of times higher than anything they could ever handle if suddenly the coupled phases were inverted, there would be at a minimum enormous explosions in the circuit breakers and switch gear, and most likely enormous explosions from within the generator windings themselves.

Suddenly, with the windings and switch gear blown in an instant, there would be nothing left to load the generator, which needs to be held back from accelerating by the electrical system it is feeding power into. You would get a brief period of rapid acceleration before safety shutoffs re-routed steam from the generator's turbines to an emergency bypass. Things would get sketchy after this. YOU NEED TO GET RID OF THAT STEAM.

At a minimum, safety valves should open on the reactor or whatever else (coal fired boiler) to release the sudden steam pressure buildup resulting from the turbine steam not being needed anymore. If the system was infected with Stuxnet, (85 percent of our power generating facilities can be) and Stuxnet was programmed to over ride the emergency steam release valves, as was the case at Fukushima, things WILL explode. Said explosions would not be minor. The worst possible case scenario would be a nuclear reactor which was running at full output suddenly not having it's steam be needed anymore, be kept at full thermal output by a virus that also forces all the safety related equipment to not activate.

Clandestine military action is the only reason any thinking engineer would want to suggest acceptance of variances in the grid frequency. There is no possible way to derive any sort of benefit from not keeping the frequency dead on, as it has always been.

But it gets worse, even

Every motor powered device depends upon the grid frequency to regulate how hard it runs itself. All of the design characteristics involving material stress and current draw are centered around an always-reliable 60 hz frequency. If the frequency was increased to 70 hz, swamp coolers would burn up from trying to run too fast, as would air conditioners, washing machines, etc. The amount they are talking about in the article would not be that high, but I believe it is the end goal and introducing the concept of tampering with the frequency is like a toe dip to see if there are any piranhas out in the public sphere to look out for while they slowly weaponize the power grid. I will happily provide the first bite. What if they choose 90 hz? 100hz? Not much would survive that, and whatever did would not be the same anymore. Welcome to the third world.

Here is a great quote to rip, this is an outright lie!

Some parts of the grid, like in the East, tend to run faster than others. Errors add up. If the grid averages just over 60 cycles a second, clocks that rely on the grid will gain 14 seconds per day, according to the company's presentation."

There is zero frequency variation on the grid between east and west coasts. It is physically impossible for them to vary by even 1/10th of a cycle (1/600th of a second) per year. ANY drift will cause immediate phase cancellation with other parts of the grid resulting in immediate grid failure. The entire grid HAS TO go up or down SIMULTANEOUSLY. There is NO SUCH THING as a frequency variation in relation to another connected area.

This entire report is such a bold faced stream of BS and lies, I am blown away to think they would ever consider trying. This is downright brazen

I know many readers believe the end is near for this nation. Proposals like this prove it. Even worse is the attitude of AP. Did they not consult anyone who actually knew what this would do, other than the enemy? Are THEY the enemy?

They will do this if we do not speak up. If you want this nation to have a future, I strongly suggest you make it perfectly clear that the GRID IS NOT TO BE TAMPERED WITH.

UPDATE:

These comments are in response to people who e-mailed me telling me the grid was now running DC, which would, if true, make my main premise irrelevant.

My response follows

I know that on many of the big transmission lines they are indeed using DC on VERY LONG RUNS of 400 miles or more because it allows higher RMS throughput and minimizes inductive losses, but it is not always the case. None of the big lines in my area are that way, and AC distribution is still so

predominant that playing with frequencies on a grid as great as ours is the equivalent of handing a Ferrari over to a tinkering teenager. I will not budge on my major premise, that phase conflict issues will indeed force the grid to operate in isolated pockets if an experiment with different AC frequencies is allowed, and that anyone who is suggesting it should be allowed to run with frequency variations should be the subject of GREAT scrutiny and suspicion.

How much of the grid, exactly, uses DC/inverter arrangements? VERY LITTLE. And it is ALL on remotely situated lines of enormous length. You will find few of these types of lines if ANY east of the Rockies. These are mostly in the desert southwest. East of the Rockies, where long runs are not needed, whether or not DC will save you money has to be calculated against cost of equipment and losses of power in that equipment. Rectifiers and inverters do not run with perfect efficiency, there are losses and if those losses add up to more than what the AC inductive losses over a stretch of line would be it makes no sense at all to use them. Furthermore, if an arc ever starts on a DC line, there HAS TO be a short power outage to extinguish it. AC lines self extinguish in one cycle automatically.

Despite a few people saying DC makes my suspicions irrelevant, upon checking for recent technology changes I found I am completely correct and I am not budging on my main premise - that there is no rational reason to tamper with the grid frequency.

Also:

Phasing is everything. Get more than 30 degrees before or behind the phase and you are toast. If you do not understand why frequency matters, stay off the subject. It's not a matter of ideal or not ideal, it's a matter of POOF!. You may think you are doing a service by going around telling people I am full of BS, but it is very common for electricians to not understand what functions frequency performs and it is beyond virtually all of them to understand that you cannot have two dominant frequencies from different sources on the same line without encountering severe problems.

Frequency matters a LOT MORE THAN VOLTAGE, INFINITELY MORE because excess voltage does not go on a continuously proceeding march forward. A high voltage on a line will stay where it is, but a different frequency will walk forward on a phase until it lands directly opposite. Things will trip out long before that happens. Any frequency deviation between two signal sources will put one source waveform negative to the other source positive very rapidly. A full phase misalignment will represent an RMS voltage difference between both sources that is TWICE the RMS voltage of each source if they are the same voltage to begin with, and they are 180 out from each other. Yes I know 3 phase is 120 degrees per phase but I was not all too excited about trying to explain three phase power in an article mostly read by people who do not deal with electricity.

I have seen countless electricians mistake harmonics for "frequency variation" and then run around saying the place runs on "70 HZ!". Harmonics can be pesky, but they are NOT the root frequency, and if your meter is telling you there is 70 hz on a 60 hz line, there is either a severe overspeed on your generator or you are picking up a harmonic. Suspect a harmonic. Meters will often do that, and it has nothing to do with root frequency. Not understanding this is very common among average electricians.

My reference was for single phase AC because I did not want to try to explain 3 phase power to average people. My report was not written for electricians, it needs to hit the masses to make a difference.

I am dead right about inverted phases and frequency creep, interconnected systems have to hit the EXACT SAME FREQUENCY DEAD ON, even being off a fraction of a percent will quickly be the equivalent of shorting opposite phases.

Leading the phase and lagging the phase DOES NOT CONSTITUTE A FREQUENCY DIFFERENCE. Lots of places might try pushing the phase to get more power out or correct a lagging power factor. That is not the same thing as producing a different frequency altogether. That is something I did not put in the report because it is far too complex for average people but I know there are plenty of electricians

out there who actually think that pushing the phase requires you to run at a higher frequency; it does not. It changes the shape of the output waveform unless too many power facilities do it simultaneously, and then they all go up together, there is NEVER a "different" frequency on the grid in one location in relation to another. The entire premise of this report is that there can never be two different root frequencies present on the grid. It is not possible to have that happen, and if the East ever does run up to a different frequency it will require being disconnected from other parts of the grid which are running slower. On an interconnected grid that should not happen, it should all stay at the exact same frequency between interconnected regions. The AP report clearly states that they want DIFFERENT FREQUENCIES ON THE SAME GRID. THAT CANNOT HAPPEN UNLESS REGIONS ARE NOT CONNECTED.

I am sure there are a few who will comment about the fact that capacitors are used to correct a lagging power factor, but there are many ways to do it. Capacitors are ONE WAY to correct lagging power factors but when it comes to heavy duty correction, they are lacking compared to running a synchronous motor with an over excited field or a generator dedicated to pushing the lag forward. Linemen do not come across anything other than capacitors. There are other ways.

And even if short distribution lines were running isolated regions by inverter only, For what reason would we have to accept frequency inaccuracies amounting to 14 seconds a day? Cheap dollar store watches can hit that accuracy, so what plausible reason could be offered to support accepting it when any inverter used on a distribution line would cost hundreds of thousands of dollars? Can't put a \$30 part in it to keep the frequency to within a half second a day? HOGWASH! They ALL have the ability to output very accurately. Nowadays we should be demanding a MORE ACCURATE GRID FREQUENCY, if it could be done; IT CANNOT.

Don't allow scammers to "fix" what is not broken!

Here is what followed that introductory line, and the reason why we need to oust the FED and start over.

The following is what he said in the interview

I started in the American nuclear program all the way back at the time of the Manhattan project, and have been involved in reactor design and nuclear engineering my whole life. There was one answer we all searched for, and it was how to close the nuclear loop.

When a reactor such as a boiling water reactor uses fuel, the waste products, which are highly radioactive isotopes that have a different fission characteristic than the fuel, build up in the fuel and poison the nuclear reaction. A reactor such as a boiling water reactor can only use the fuel until it gets contaminated by these isotopes enough to change the nature of the nuclear reactions taking place. The reaction environment inside a boiling water reactor is only one such environment that will work to trigger a chain reaction, and if that spent fuel is put into a reactor made from different materials, those materials can favor the burning of the poisonous isotopes, and use the isotopes as fuel until the fuel is purified of them, and therefore had it's original radiological characteristics restored. Once that is accomplished, the fuel can go back into the boiling water reactor, and used as new.

We perfected the second reactor design, which used liquid sodium as a coolant, and the reactor ran much hotter - 1100 Fahrenheit as opposed to 550 in a boiling water reactor. The liquid sodium circulated inside the reactor in lieu of water, with the heat of the reaction being removed from the system by a heat exchanger (which boiled the water outside the reactor for use in producing electricity). The temperature difference and coolant characteristics facilitated the burning of the isotopes, and you got to use both sides of the reaction - one side produced electricity while poisoning the fuel, and the other side produced electricity while burning the poisons out. This process can be repeated 20 times, and when it is finished the fuel is DEAD and no longer hazardous because all of its radiological potential has been used up. It was a dream come true, and Carter banned it by executive order!

He specifically stated that the burn down was so complete that the spent fuel was safe to handle directly with bare hands, and needed no special care or maintenance at all.

He then went on to lament about what a waste of money it was, because the fuel is expensive, and they were only using it to about five percent of its total potential. He lamented the fact that his life's greatest accomplishment got banned for no good reason, and it was a tremendous waste of money to not use the technology his team developed. Electricity would have been cheap. REAL CHEAP. So cheap that homes would not have been heated with oil or natural gas, electricity would have been the only sensible choice. Furthermore, with a reduction in the price of electricity by at least 10X, electric cars would have been a no brainer.

His take on it was that we were now paying too much for electricity. I guess that's how an engineer thinks. He had read my article on Fukushima and liked it, so one would guess his eyes were open to the global conspiracy. Even still I think he missed the obvious in what he said.

When GE and others designed the nuclear facilities both here and abroad, they had calculated that they would indeed succeed in closing the nuclear loop. It was my impression from this engineer that they got it sooner than expected. So fortunately the fuel pools were over built. But they were never built to withstand the fuel burdens that would result from a political decision to destroy the technology altogether.

So now, 40 years down the road, we have fuel pools around the country that are so full that they have exceeded even the extremely generous safety margins they were originally designed to have, and even modest pools often have over 400 tons of highly active isotope ridden "spent" fuel in them.

Having functional fuel pool cooling systems was never intended to be necessary. GE and others wanted one or two cores worth of fuel sitting in a pool at any one time. This would make it so that even if all cooling failed, there would be no boiling of the water in the pool, no pending disaster possible from equipment failure no matter how severe. I am going to release a preliminary version of the report tomorrow before I go on the air, for people to look at for reference.

I interviewed an 85-year-old nuclear engineer who worked for GE and designed the reactors at Fukushima. He had nothing new to contribute about the reactor design, etc (not that the public would understand) but after answering my questions he went on to tell me something very interesting.

You guys probably might find this hard to believe, but I am going to tell you exactly what he told me.

He said that the team he was on at GE succeeded in closing the "nuclear loop". I did not know what that was, and he went on to explain -

When fuel is consumed in boiling water or other water-cooled reactor it produces isotopes, which poison the chain reaction and produce unfavorable conditions. Once the isotopes build up to a certain level - he said about 5 percent depletion of fuel, their presence becomes dominant and it interferes with proper reactor operation. So the fuel has to be pulled out.

GE was working on a technology to do away with this problem, and here is exactly how he described it. He said NOTHING about re-processing, NOTHING AT ALL. HE SAID IT JUST LIKE THIS:

You take the fuel out of the water-cooled reactor and put it in a sodium-cooled breeder reactor. Because the materials used in the breeder reactor favor the burning of the isotopes, (one of which was liquid sodium for cooling) and also because the reactor runs much hotter (1100 Fahrenheit vs. 550 in a BWR (I filled that in, I studied them well enough) ONLY the isotopes are burned off in the breeder reactor, and once their interfering characteristics are removed from the reaction, the fuel, at 5 percent depleted works perfect when put back into the boiling water reactor, with NO REPROCESSING NEEDED AT ALL. He said that this process could draw the fuel almost all the way down. He said it was good for 20 cycles. I don't know if 1 BWR cycle and 1 breeder cycle equals 2 cycles, it would make sense, but he was also adamant that you get a LOT of performance out of the breeder reactor, which can produce substantial power by vaporizing water in a heat exchanger during the isotope burn out. The impression he left indicated that the fuel was almost completely dead at the end of the process, though I don't know how you could get any performance out of it once it was used past 50 percent. I would expect reprocessing to be needed at that point, but that is not how he phrased it.

Carter banned this technology by executive order on his third day in office, and as a result, 25 tons per gigawatt per year have been building up in fuel pools across the country. GE never intended to have the fuel pools filled, they expected to have the technology fully perfected by the mid 70's and succeeded in this goal, only to have a political decision shut it all down.

He lamented the buildup of so much fuel at American nuclear facilities, mostly from an economic standpoint. I lamented the buildup because it is a FREAKING HAZARD. The fuel pools were NEVER designed to have so much fuel in them, GE's original intention was to have maybe TWO reactor core's worth of fuel in a pool, not 40. So the fuel pools are overloaded now, and if ANYTHING happens, a war, a collapse, etc, and the nuclear facilities are not maintained, these fuel pools will go ballistic and wreck the country.

SO

My main focus will be to try to convince people to do something about it - to overturn that executive order and allow the miracle GE created to be used to burn this fuel off, which absent selling so much fuel would require America to run on ONLY nuclear power for at least 80 years. My fear is that the



legislation was put in place to weaponize America's nuclear program to be used against us in the future. It's a little hard to argue with because:

1. This technology would have extended the life of the fuel by 20X according to this engineer, which would mean that after all these years AT MOST there would be two cores sitting in each fuel pool as opposed to sometimes 40,

2. France offered to pay us billions for our "spent" fuel which is in fact very valuable, while our government instead opted to just let it build up and then pump the nuclear waste propaganda endlessly, to make people fear and hate nuclear power. There was never a need for this; with reprocessing and the "closed loop" cycle, there should not be ANY nuclear "waste" ANYWHERE. It's all a scam and hoax. According to this engineer, the reprocessing he spoke of is NOT what the French are doing now. It was a better solution.

I will be back to see if this passes muster on this forum, if anyone has any comments, NOW IS THE TIME FOR THEM, I will discuss this on THURSDAY.

The Fort Calhoun nuclear facility is located on the Missouri river 20 miles from Omaha Nebraska.

This facility has already suffered one fire which led to loss of cooling in the spent fuel pool and triggered a level 4 nuclear emergency - the same as Fukushima before there were explosions. A second fire has also taken place with no other information available.

The facility has leaked water from the outside in, but for now the situation is under control and power has been restored to the cooling systems associated with the spent fuel pool. Problems with the spent fuel pool allegedly led to excessive condensation, which sparked the fires in electrical systems associated with the fuel pool. A small amount of radiation was released, and the facility was evacuated for causes associated with the fire.

The facility has been in cold shutdown and will not be restarted until flooding subsides.

With dams up stream at maximum capacity, and record snowfall runoff predicted, the future of this facility is uncertain. I was surprised when on Wednesday, June 15 after the first fire, which triggered a level 4 emergency (the initial emergency for Fukushima), that the media was not all over this story. 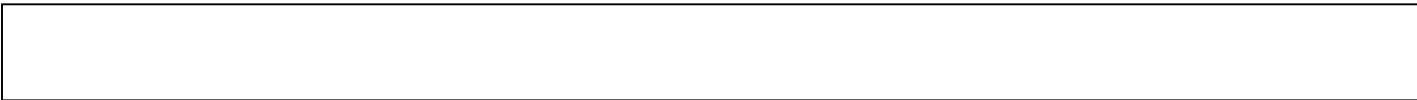
UPDATE: Yahoo news FINALLY reported on JUNE 26th that the dam surrounding the switchyard failed. But if you look at the photo I posted on the 15th, you can see that it failed long ago. Why on earth is the reporting out of here so slow in the "mainstream press"? Yahoo also reported that the facility lost main power as a result of the dam break and had to run on generators until new lines were run into the facility.

Since the photo above was taken, the waters have risen no less than six additional feet. There have been numerous reports of no-fly zones being issued across the country, and lack of pictures of this facility since the 15th clearly indicates that air traffic has been stopped to prevent the REAL situation from being photographed, and not as a result of normal air traffic restrictions around nuclear facilities.

I could not confirm the accuracy of the report that workers had to enter this facility from the second floor windows, but it only makes sense. I will provide a map with this special Japanese report showing the areas outside that I believe will kill you when I am finished analyzing photos for that purpose.

The contamination is worse than Hiroshima and Nagasaki by far for many reasons. The main reason is that the nuclear weapons used at Hiroshima and Nagasaki did a good job of cleanly burning the nuclear fuel down to highly radioactive isotopes with short half lives, and the amount of nuclear material in a weapon is a lot less than in a fuel pool at a nuclear facility. The short half-life isotopes produced by a nuclear weapon means that at Hiroshima and Nagasaki, the radiation levels were dramatically less even a few months later. This will not be the case at Fukushima Daiichi and the entire Fukushima prefecture.

Since the radioactive debris at Fukushima Daiichi is reactor fuel, the half-lives are thousands of years for a large portion of the materials. This is because it is mainly Uranium and Plutonium, which have very long half-lives. So the radiation will never go away for as long as you or your children live, the contamination levels will only drop as rain erodes the contaminated soil away. This will not happen in your lifetime - It could take thousands of years. Furthermore, there will be never ending problems with hot zones, where erosion and deposition concentrate radioactive materials in small areas that produce very high exposure levels. This would be mostly in places like storm drains and riverbeds.

There are enormous variations in stated threats from radiation exposure. Some sources say that 250 millisieverts a year have produced no ill health effects in populations subjected to that dosage, while others say that even small dosages produce damaging results. This report, produced by the world nuclear association makes it look like you could use a piece of a reactor core as a hood ornament on your car and be just fine your whole life. I would call this report an extreme understatement of the threat from radiation; I am only linking this to provide an opposing view. I find it completely implausible that 250 millisieverts a year can be found naturally in Iran and the people take it just fine, with no ill effects when uranium mine workers only get 20 millisieverts of exposure a year. In Russia, a pine forest died from Chernobyl, and plants can withstand a LOT more radiation than people can. The fact that Russia evacuated people at 5 millisieverts a year really makes the report suspicious. Russia has never been known as a champion of environmental health. But it is an alternative view, apparently well done.

The following evacuation calculations are for milliseverts PER YEAR.

I wrote these recommendations based upon my education, without using reference from ANY government agency in ANY nation, or any sources at all, because I do not trust them. After finishing my calculations I then looked at what Japan is recommending and was very surprised. MY NUMBERS ARE MAXIMUMS IN MY OPINION, AND ARE NEARLY IDENTICAL TO RUSSIA'S EVACUATION GUIDELINES FOR CHERNOBYL. THIS PROVES I GOT IT RIGHT. The Fukushima disaster is worse than I thought. THE JAPANESE GOVERNMENT'S EXPOSURE LEVELS MAY HAVE BEEN ISSUED IN DESPERATION

I hate to say this

50 millisieverts a year? 10x Russia's evacuation level for Chernobyl.

My original statement follows; I never dreamed the Japanese government would consider 50 milliseverts a year OK. I made no corrections to my original recommendations after seeing Russia's evacuation standards for Chernobyl, because my numbers are close enough and radiation exposure has a subjective factor.

I would not accept living in an area with 30 millisieverts PER YEAR, ABOVE normal background radiation. That would mean that if I lived to be 100 years old, I would have, over the course of my life, received a half lethal dose if I got it all in a day. DNA is pretty good at repairing radiation damage so I might not ever notice anything seriously wrong day to day HOWEVER, There are MANY little pieces of evidence which suggest 30 MSV/YEAR is more than just an increased cancer risk. Airline workers flying high altitude routes typically die at age 62 if they DO NOT retire at age 50, and their radiation exposure is usually a LOT less than even 10 msv a year. Whether or not early death in late retiring airline pilots can be blamed on high altitude radiation has never been proven or disproved, but THERE IS A REASON THEY DIE EARLY and I do not believe it is work related stress. They sit all day as a backup while the plane flies itself, and are usually only active during takeoff and landing. Furthermore, uranium mine workers who typically receive 20 msv a year have dramatically increased cancer rates and early death, so while "official" sources say there is nothing to worry about, empirical evidence suggests otherwise. I would never live in a location with 30 MSV a year, but I would drive through it if it wasn't every day.

I might consider working a job in an area with an exposure level of 10 millisieverts PER YEAR, above background levels if I could drive home to an area that had zero. If I both lived and worked in such an area it would mean that over a course of a lifetime I would receive radiation exposure that would make me sick if I got it all in a day, but I would recover from it eventually. While living in such an area, I would not notice anything wrong. But I would be at an increased risk of cancer. If I did not get cancer, my life would be pretty much normal, but the chance of getting cancer would be higher than otherwise. If I did not already own a home in such an area, I would not move into one there, but would not move out in a hurry either. I might take a year to finally decide to leave and would definitely eventually leave.

I would feel pretty much safe at an exposure level that was 3 millisieverts a year above normal background radiation. You have to make choices in your life, and what you consider a risk. Driving would be a similar risk to the radiation. I would be more at risk for cancer, but how much more would need to be considered. I of course would rather live in an area that was zero radiation above background, but I would buy a home in such an area if it was advantageous. People who live at high elevations and airline pilots usually get more than this per year. Consider 3 millisieverts a year a safe level.

If the radiation level above background was 1 millisievert a year, I would be aware I lived in a contaminated area. I would go to bed at night with only a casual thought of being in an area that saw a disaster, and not really let it bother me. Of course I would rather be in a location that was at zero above background, but would never consider one millisievert a year to be a threat.

If the radiation level was 500 microsieveverts over background per year, I would consider myself to be living in a contaminated area, with a virtually non-existent threat. I would be very likely to ignore it entirely. Major cosmic events could possibly exceed this dosage.

If the radiation level was 100 microsieveverts over background PER YEAR I would not consider myself to be living in a contaminated area. I would know the radiation level was higher than average background but I would never give it a thought. DNA is good enough at repairing itself to pretty much eliminate any cancer risk. Cosmic events could expose me to more radiation than this.

Here are the numbers, when calculated in exposure per hour:

30 millisieverts/year = 3.422 microsieveverts/hour EVACUATE ASAP, safe to drive through and visit for a short time.

10 millisieverts/year = 1.141 microsieveverts/hour EVACUATE AT YOUR CONVENIENCE, BUT DEFINITELY EVENTUALLY LEAVE.

5 millisieverts/year - Russia's evacuation threshold

3 millisieverts/year = 342 nanosieveverts/hour My calculated evacuation threshold. 5 could be OK.

1 millisievert/year = 114 nanosieveverts/hour

500 microsieveverts/year = 57 nanosieveverts/hour

100 microsieverts/year = 11.4 nanosieverts/hour

Keep in mind that my advice is subjective, and that there is no radiation exposure that presents zero risk. Radiation does not work that way. Consider this the advice of an intelligent man who cares about those who read this and wants to avoid undue panic in Japan. I also want to provide advice to the Japanese people that will help them avoid situations that are definitely dangerous. Now that the Fukushima article has had thousands of reads in Japan I have a responsibility to inform, and hopefully these numbers will not ruin too many lives. I really hope the numbers there are not higher than this where you live, if any number is near or over 20 millisieverts/year, I would move as soon as possible in every case!

THE ONLY WAY SUCH HIGH RADIATION LEVELS COULD EXIST IN JAPAN IS IF A NUCLEAR WEAPON BLEW FUEL POOLS AWAY. JAPAN IS THE VICTIM OF AN ACT OF WAR. THERE IS SIMPLY NO OTHER WAY. Indeed it is much much worse than I thought, even knowing there was a nuke. Your nuclear program was much much better than Russia's and was delivered a disaster worse than Chernobyl. It was an act of war by a foreign country because Japan offered to enrich uranium for Iran.

I strongly suggest individual cities and wealthy people buy their own Geiger counters. This can provide comfort if the government is telling the truth, and a warning if they are not. Expect to pay four digits USD for a good one and remember, they need scheduled calibration

# Digital Stepping in the Aurora Borealis - An Analysis of HAARP

Understanding the technical side of HAARP ([back](#))

It is a cold hard fact that even if the entire electrical grid output was used for weather modification, there would be insufficient power available to do much of anything. The distances are too wide, volumes too huge, and locations in relation to a transmitter seldom ideal. Yet weather modification is a reality. How? This article explains how it can be done, from a scientific perspective.

Most everyone has heard that silicon is a semiconductor. A semiconductor only permits current flow when the conditions are correct.

In a typical silicon semiconductor, it's current flow characteristics are determined by the addition of doping agents - these are mixed with the silicon and become part of it's molecular matrix during the manufacturing process. The two most common doping agents are arsenic and boron.

Doping agents cause the silicon to have an excess number of electrons in the P doped regions, and a deficiency of electrons in the N doped regions. A small electronic charge applied to the junction between the N and P regions will cause a cascade effect of a much greater magnitude if a power supply voltage is applied to one side of the piece of silicon, and a load is applied on the other side. That is what makes a transistor, the heart of a basic amplifier.

How HAARP works, and a possible real reason why there are "chemtrails"

Most people do not realize this, but common air - the air we all breathe, is also a semiconductor, and it can be made to behave just like a piece of silicon if the right doping agents are added to it.

If you wish to modify the electrical characteristics of the atmosphere, you need to use an aircraft to disperse the doping agents at a high altitude. If you then take a pair of huge transmitters, such as HAARP, and transmit a frequency to a specific region which is timed to phase cancel against the opposing transmitter the frequencies they transmit will vanish and leave a standing DC bias voltage in the atmosphere at the selected region.

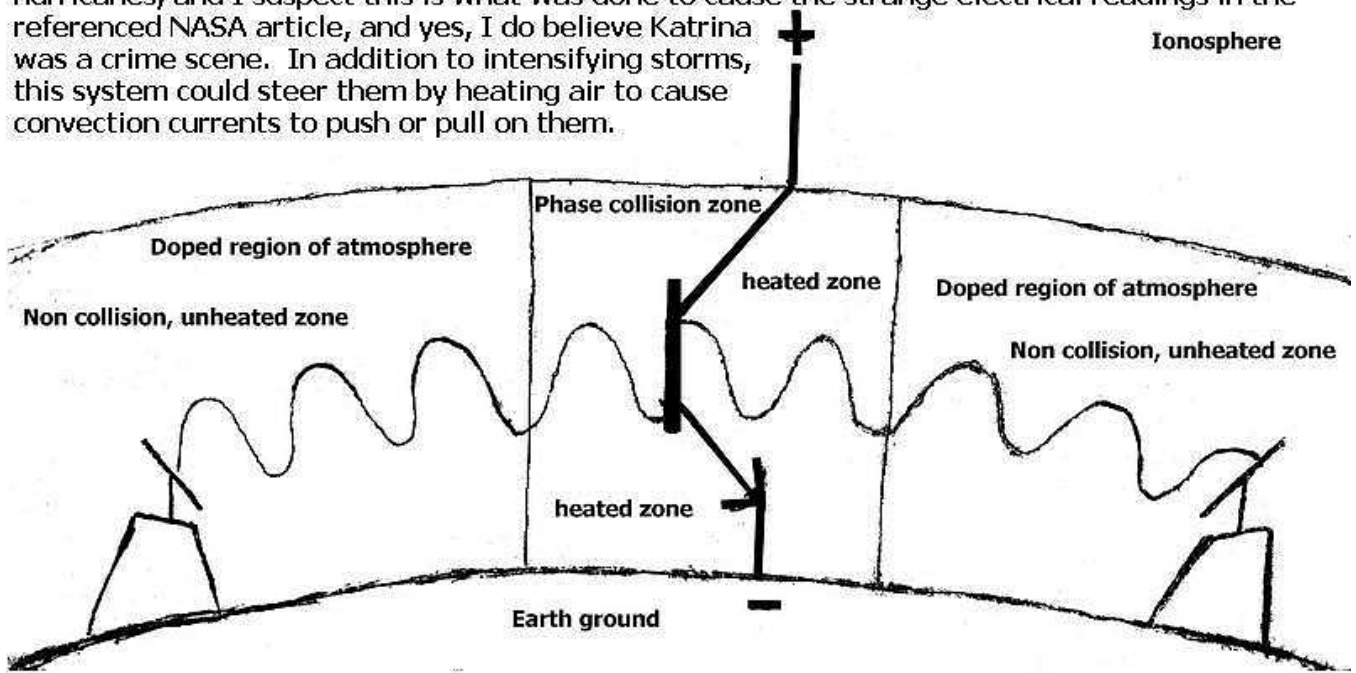
This voltage is the electrical equivalent of the electronic charge applied between the N and P regions of a silicon transistor. The chemtrails are the doping agent, and the ionosphere is the power supply.

A flow of current is then triggered from the ionosphere to the earth below. Because the ionosphere has virtually endless power to give, it is possible to take a transmitter pair with a radiated power of only a couple of billion watts, and use it to trigger a cascade of trillions of watts. That is enough to heat the atmosphere, and trigger a change of climate, storms, etc. It is very important to make sure you do not exceed certain limits, or "clip" the atmosphere, or you will cause a lightning bolt of a sort not ever witnessed. But if kept below certain thresholds, a great amount of atmospheric heating can be caused and no one on the ground would ever notice a thing.

This of course would cause very odd electrical readings in the atmosphere. So someone should have been able to detect this, right? NASA did. They noticed several hurricanes, including Katrina, were not electrically normal. These were the only 3 hurricanes to ever be that way. This could be done using the method mentioned here.

The following image is a drawing of how a HAARP type system could be set up to work.

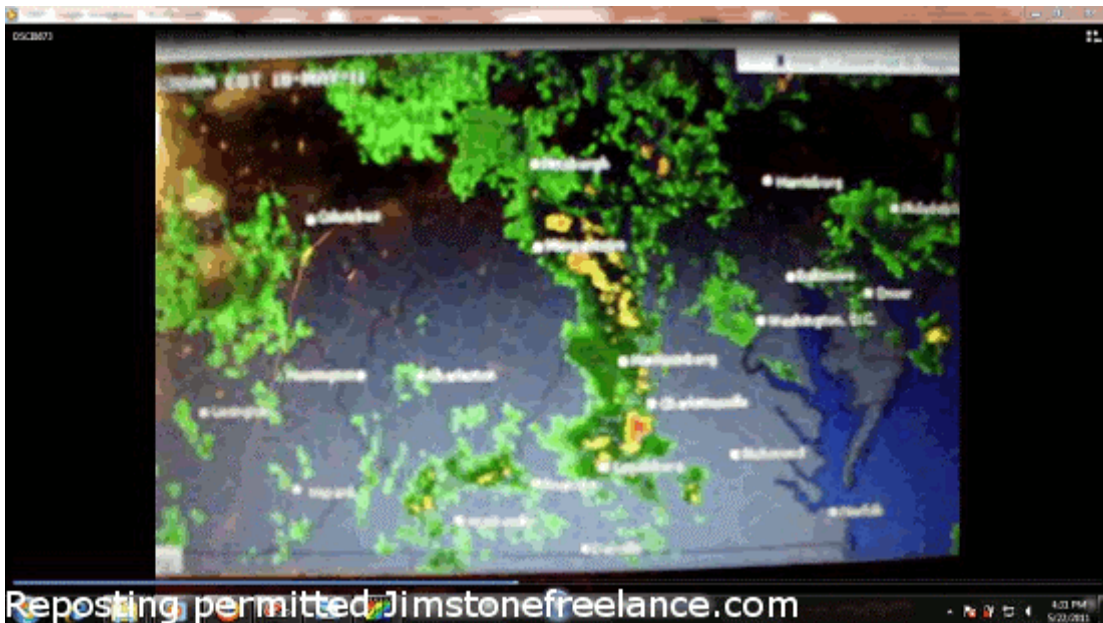
The traditional "HAARP" type system would need a counterpart elsewhere in the same hemisphere of the globe. The signals could be directed and timed to phase cancel anywhere within reach of both signals. At the intersection point, they could be caused to drop a static bias electrical field into the atmosphere, which in the presence of a doping agent (chem trails) could trigger a cascade of electron flow from the ionosphere to the ground, thus heating the air in the electron path to trigger and intensify storms. This is a theoretical stab at a classified system by a knowledgeable engineer. Since this system is classified, this guess is probably the closest thing to the truth you will ever see. This would be effective for beefing up hurricanes, and I suspect this is what was done to cause the strange electrical readings in the referenced NASA article, and yes, I do believe Katrina was a crime scene. In addition to intensifying storms, this system could steer them by heating air to cause convection currents to push or pull on them.

Someone on Godlike Productions opened a thread about a weather anomaly in progress out East. I clicked on the link and my jaw dropped.

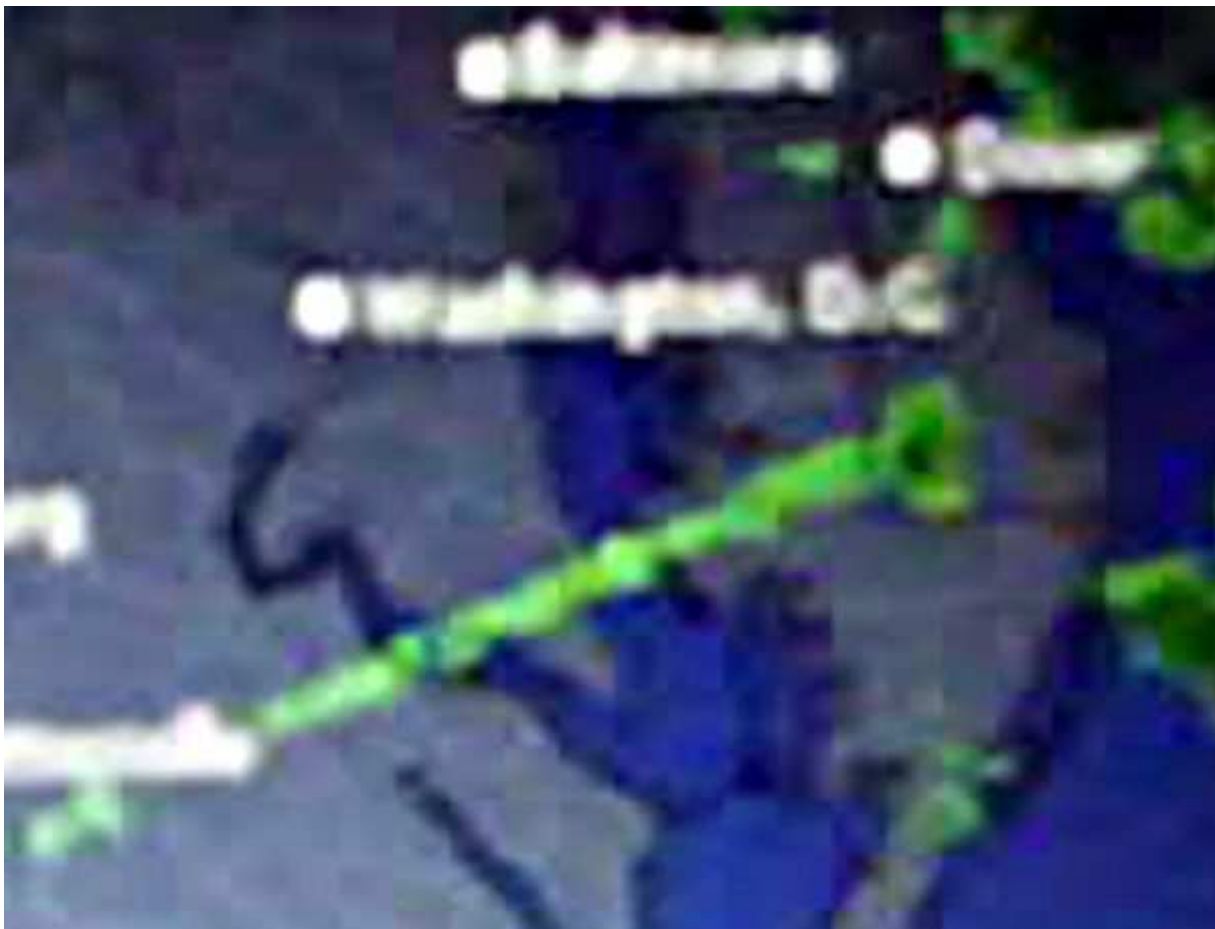

Here, I cut the frame for reference

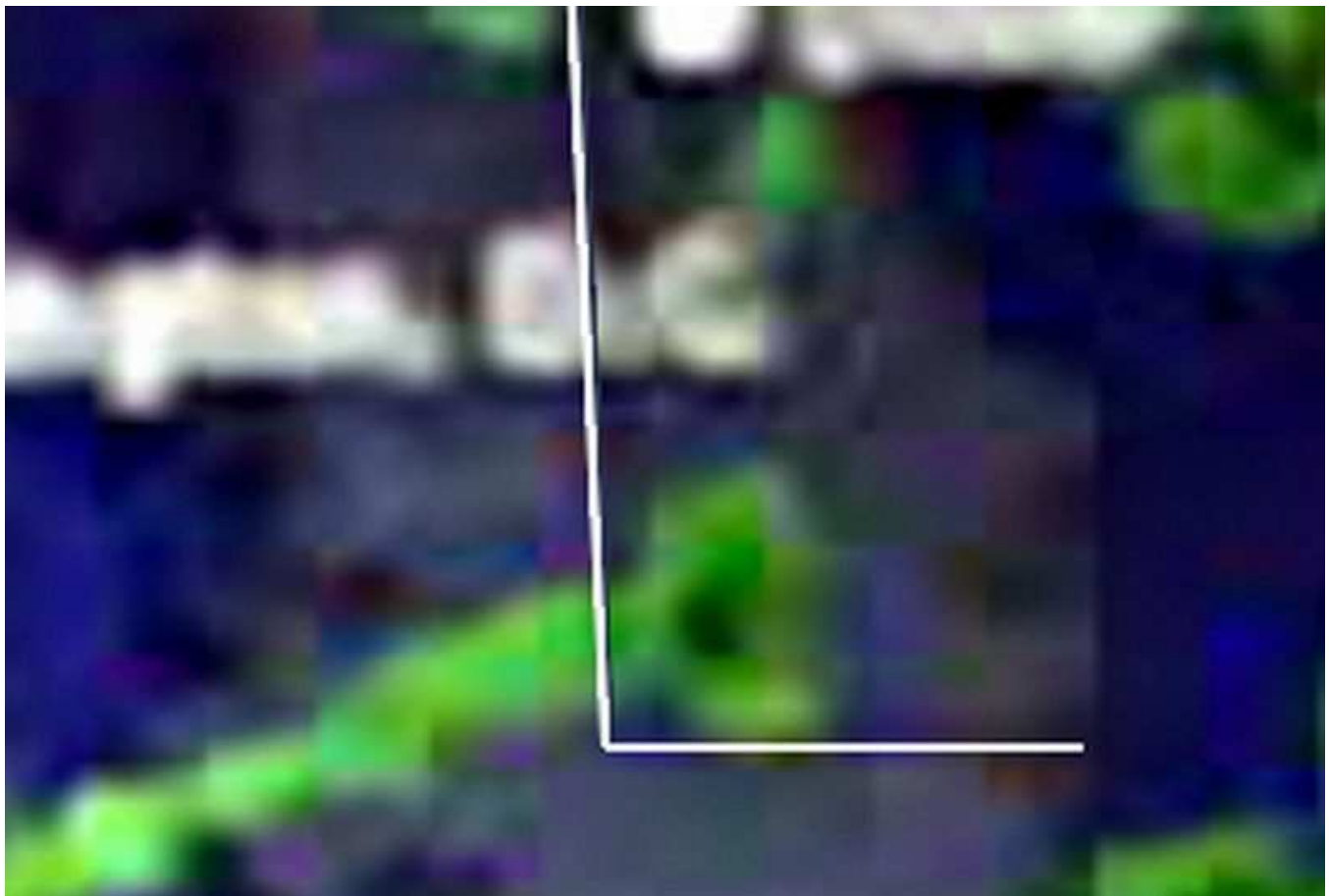




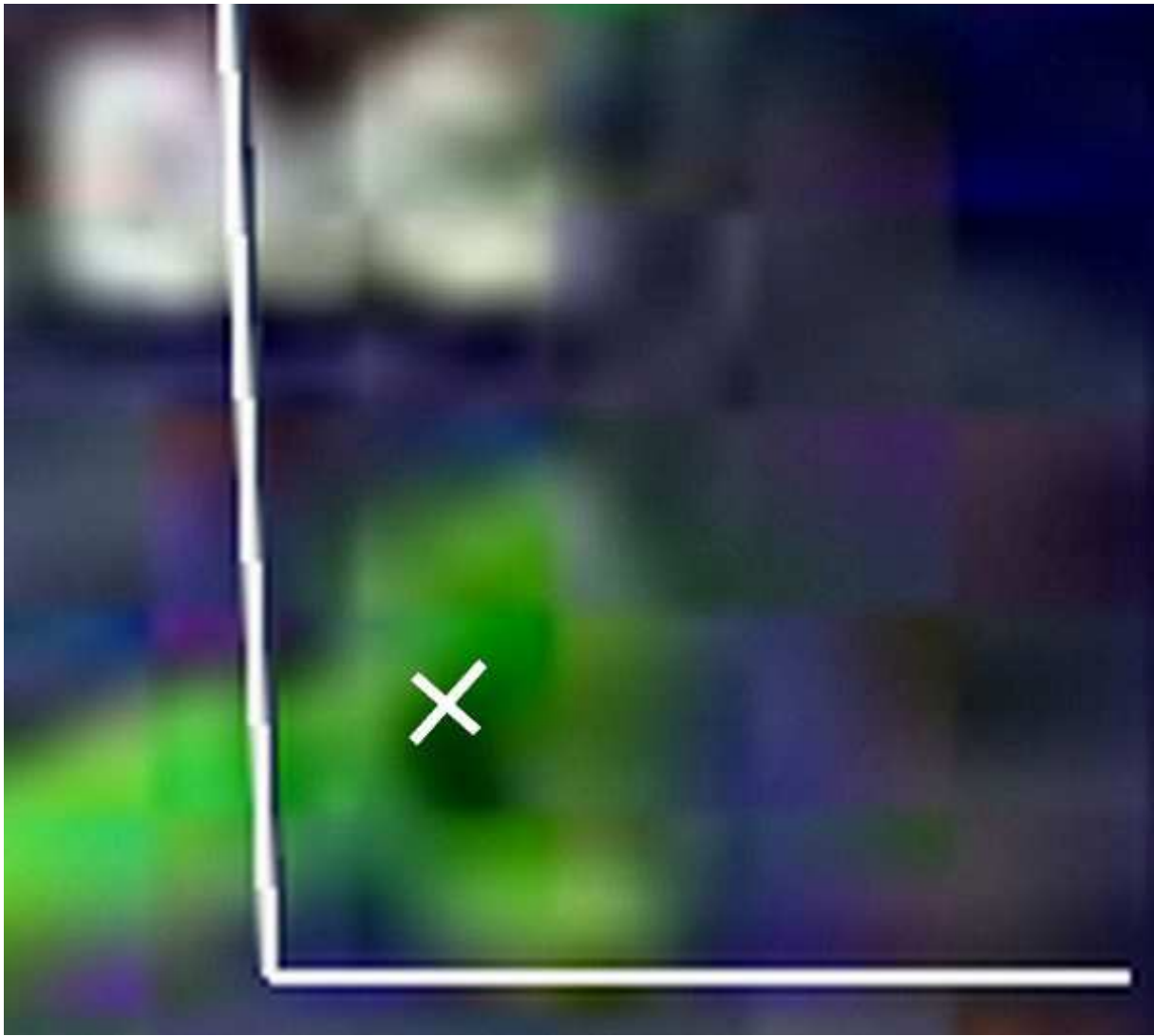
Here I cut the image down to include only the anomaly



Here I zoom in more, and prominently outline the Delaware border.



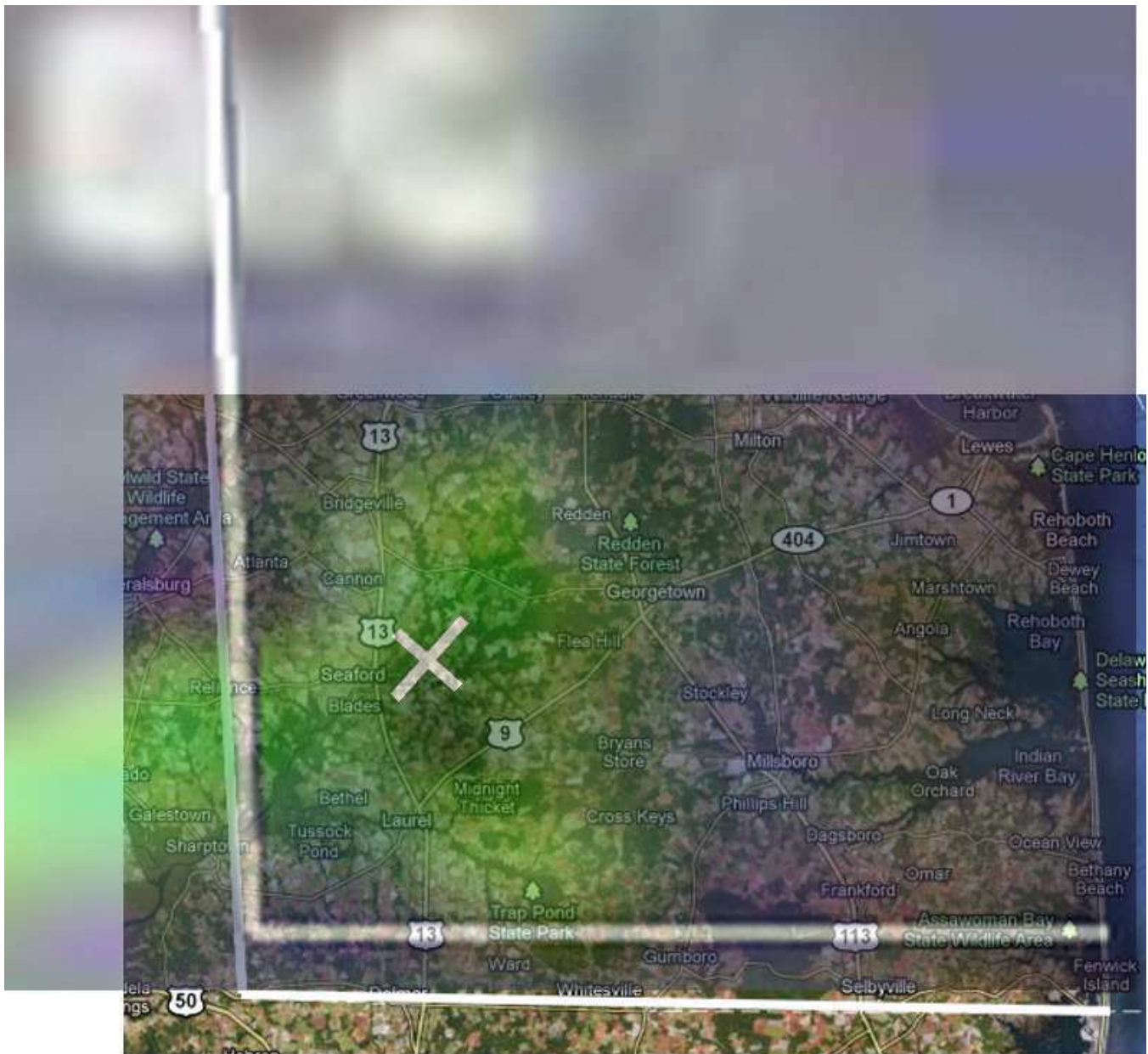
And more. I also place an X where I think the beam might be originating.



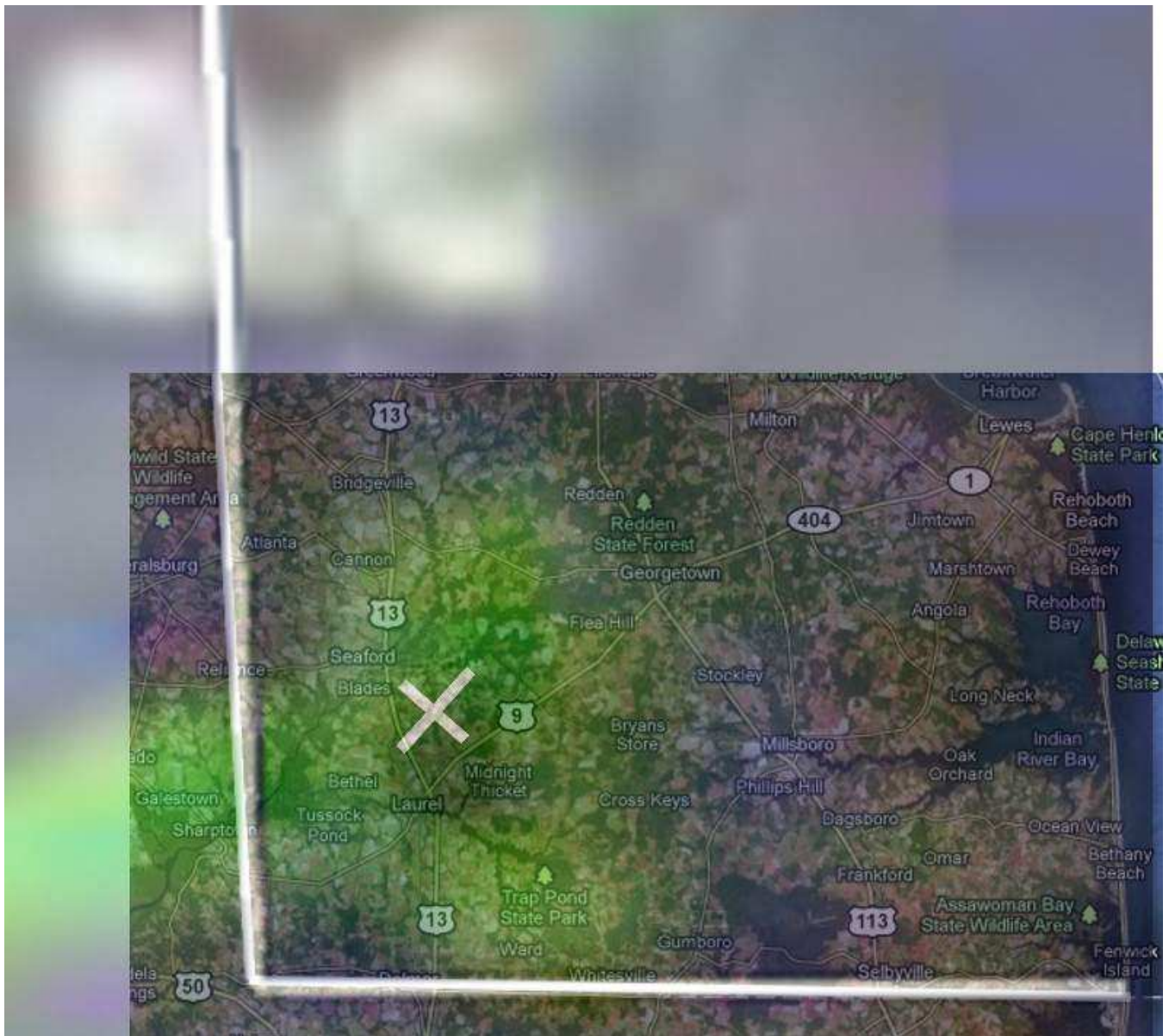
I then pull up the same area on Google maps, satellite view, and outline the Delaware border.



I then merge them partially, to let you see what I am doing

Now I fade the top layer, to reveal the Google map below, with the X still faintly visible. I want everyone to search the region around that X to see if they can find the transmitter.



One thing you cannot see clearly in the animated gif because of camera shake is the fact that the weather system was moving the wrong direction. It should have been proceeding up the Atlantic coast, instead it is heading over the Appalachian range and down into the Ohio valley. If you look at other weather maps from the center of the country, you can see that the storms are following the Mississippi and then hooking left, to follow the Missouri river, and then on up into Alberta. This is not the normal weather flow. The storms along the Mississippi should be pushing across the great lakes on up into Ontario. I am worried that the weather systems causing the flooding may be doing so because of weather modification. NASA documented that three hurricanes had extremely strange electrical readings, one of which was disastrous. That is empirical proof of weather modification beefing up the hurricanes.

"The H1N1 vaccination program, when put into the same frame as the engineered virus to go with it, appears to be a clear effort to divide humanity into two groups; those who have lost their intellect, health and sexuality via a tainted vaccination, and those who have not and are therefore superior."

I met the story about the swine flu with great skepticism; it played like a story line in a B movie - Students go abroad for spring break. Students get the virus. Students bring it home. Worldwide pandemic starts. The story line was unbelievable, and I knew from day one that there was either no virus at all, and that it was just a "wag the dog", or that a manufactured outbreak was intentionally released and underway.

Unfortunately the latter was true, and now we have an entirely new bug on our hands. It has never been seen before, and virologists have been quoted saying "where the hell it got all these genes from we don't know." Extensive analysis of the virus has revealed genes from the original 1918 flu, the avian flu, and two new H3N2 viruses from Eurasia. All evidence points to the fact that the swine flu is indeed a genetically engineered virus.

This article is the result of a team effort intended to explore what the motive for releasing it may be, to warn you in advance of things to come.

### The first attempt

In Feb 2009, Baxter, a major manufacturer of vaccines, sent the seasonal flu shot to 18 different countries with live unattenuated H5N1 bird flu. The protocol made it technically impossible for the

virus to make the leap from the research department to the vaccine manufacturing department, which could never have had H5N1 show up there due to any reason other than willful intent.

One would think that Baxter would have been put out of business for making such an "error" but the opposite is true, which begs many questions, such as how did the live bird flu end up in millions of doses of vaccine? Why were the ingredients of the vaccine formulated to allow the virus to survive fully potent en route? Why was Baxter not prosecuted or punished in any way? Instead of rightfully blackballing the company, the World Health Organization has rewarded Baxter with a contract to make a large portion of the "Swine flu" vaccinations set to be distributed world wide this fall. How on earth could that be?

The main focus

Let's switch to another aspect of vaccines, the real focus of this article, which is the plan to destroy our intellect, our health and our sexuality via a mass worldwide vaccination campaign. With the use of special additives called adjuvants, manufacturers are able to increase the number of possible doses that can be made on time for the fall flu season. But though there are many safe adjuvants which can be added, they are adding one - squalene, which has been shown to cause prolonged systemic immune response against the squalene itself, which results in reduced fertility, reduced intellect and reduced life span.

Squalene is an important molecule in the body. It is a precursor to many different oils and hormones, and is needed for proper brain function, fertility and also plays an important role in protecting cells from aging and mutation. Anything which affects your natural squalene can have a major negative impact on your health.

Because the squalene will be injected in the presence of a pathogen during the H1N1 vaccination, it will cause an immune response against not only the pathogen, but to the squalene itself. Squalene is a precursor molecule, which is essential for the production of many hormones, including all of the male and female sexual hormones. Squalene is also a precursor to many of the neurochemical receptors prevalent in the nervous system and when the immune system is programmed to attack squalene, it causes irreversible neuronal and neuromuscular damage which can range from a loss of intellect and autism to more serious disorders such as Lou Gehrig's disease and systemic autoimmune diseases and possibly brain tumors.

In independent studies where squalene laced vaccines were injected into guinea pigs, the resultant autoimmune disorders killed 14 out of 15. A later test, to verify the results had the same outcome.

When first injected via the anthrax vaccine in Gulf War 1, it permanently disabled many of the soldiers who received it, due to the effects now known as the Gulf War Syndrome. 95 percent of the soldiers who received the anthrax vaccine have been found to have antibodies to squalene. Few of the soldiers who received the vaccine remained healthy and do not have the antibodies whether or not they were deployed. None of the soldiers who did not receive the vaccine have the antibodies, even those who fought in Iraq. Squalene antibody related deaths total 6.5 percent of the vaccinated group.

It takes approximately a year for the effects to fully manifest themselves because that much time passes before the nervous system and brain deplete the reserves of Squalene that are out of the reach of the immune system and only after the reserves are gone will cell injury begin. This takes the pressure off vaccine manufacturers who deny any wrongdoing for a response so delayed. And with Congress passing legislation granting immunity to any corporations who cause damage with their vaccines, the outlook is evermore dark.

After examining the components of the H1N1 flu vaccine we can only conclude that it is not intended to treat the flu at all, quite differently, it is intended to:



1. Reduce intelligence
2. Reduce life span
3. Reduce fertility
4. Cause numerous deaths

For if it was intended for any other purpose, Squalene and other adjuvants beyond the scope of this article would not be present. Furthermore, the scope of this article only covers squalene, and we believe that because there are so many ways to induce autoimmune responses equally devastating via other injectable formulations coupled with the obviously intentional shipment of a pandemic by Baxter that the credibility of vaccines is forever tainted and the trust in the greater medical community may have been irreparably broken. Baxter should be out of business, the fact that they are not is damning.

The trust is broken

Through a manufactured pandemic and damaging vaccine the world health organization along with major manufacturers in the pharmaceutical industry have demonstrated clear intent to damage all of mankind. For what purpose is difficult to determine, but it would be safe to assume that there will be those who have been told and know better than to take one of these tainted vaccines, and as a result they will be of superior intelligence and health when put in perspective with those who receive them. Jones appears perfectly honest, and produces great and revolutionary stuff that has been researched out to the last digit. But saboteurs abound on his staff, and Jones does not "get it". Too bad, he got too big to do it all himself; the stuff HE does is un-stoppable.
